Market Commentary Week ending 10/4/2019

Below are the highlights and table reflecting last week's activity:

- Ten-year Treasury yields dropped 16 basis points to close at 1.52% on Friday.
- Ten-year AAA muni yields declined 10 basis points to finish the week at 1.32%.
- The ten-year muni to Treasury ratio narrowed by 2 percentage points from 85% to 87% by Friday.
- The thirty-year ratio narrowed by one percentage point from 94% to 95%.
