## PARENT/GUARDIAN ACKNOWLEDGMENTS

### MIAMI BEACH JCC EARLY CHILDHOOD ACADEMY (MBJCC ECA) POLICIES

- If you have any legal documents regarding custody of your child (ren), please bring a copy for us to keep on file.
- I understand that I must be a MBJCC member for my child to attend the Early Childhood Academy.
- I permit the MBJCC ECA Staff to walk my child to and from MBJCC enrichment classes, Shabbat, Swimming, Ballet, Art, Basketball, Gym, Soccer Field, and special events around the MBJCC campus.
- Tuition Includes: daily lunch, and snacks.
- I understand that my child will NOT be enrolled in MBJCC's ECA until all health and immunization forms are up to date and turned in. We do not accept Exemption for Immunizations.
- I understand that participating in any MBJCC ECA activity involves the risk of accidental injury despite all safety precautions. Therefore, as a parent/guardian in any/all activities or use in/out of the MBJCC. In case of sudden injury, I hereby give authority to any hospital or doctor to render immediate aid as may be required for my child's health or safety. I understand that all medical and dental expenses are my responsibility. I acknowledge that I am aware of the potential risks of participating in activities and/or programs at the MBJCC and agree in no way to hold the management, agents, employees, or board of directors of the MBJCC liable for any injury my child or I may sustain.
- I allow my child to attend and be escorted by staff to and from various activities (defined field trips) located throughout the MBJCC facility such as the basketball gym, art room and others during the MBJCC ECA hours.

### REGISTRATION AND PAYMENTS:

- A completed application must be accompanied by first month payment. Fees are based on ten-monthly payments from August through May. Students who enroll after the start date have a pro-rated plan, based on the number of remaining program days – this includes a June payment.
- A 5% monthly sibling discount is applied and deducted from the lower MBJCC ECA fee for each additional child.
- We understand and accept that the MBJCC ECA DOES NOT REFUND REGISTRATION FEES, DEPOSITS, TUITION FEES, OR ANY OTHER PAYMENTS TO THE PROGRAM
- I understand that families with outstanding balances of 30 days or more may be subject to a withdrawal of their child/children from programs unless alternative arrangements have been made with the accounting department.
- I understand that school closes promptly at (M-F) at 5:00PM. If you arrive later than the carpool hours, you will be charged a rate of \$10 per 15 minutes.

**CANCELLATION/WITHDRAWALS:** If you need to cancel your child's MBJCC ECA enrollment, you must notify the MBJCC ECA Director in writing 2 weeks prior. If we do not receive notification in writing a full months payment will be charged.

**DISCIPLINE & CHILD BEHAVIOR:** The MBJCC ECA program should be made aware in writing of any special needs or limitations a child may have. In the event our staff sees your child is having difficulty with the structure that we provide, we will notify you and discuss the implementation of behavior modification programs with staff and your child. After implementing behavioral programs, if your child continues to experience difficulty, we will recommend other appropriate alternatives.

**HEALTH AND SAFETY:** The Parent or Guardian certifies that the child is healthy and able to participate in all MBJCC ECA activities at the time of application. Updated school health forms are required prior to the start of ECA. Parent/guardian gives permission to secure proper medical treatment in case of an emergency, when parent/guardian cannot be reached.

**CORONAVIRUS:** Coronavirus, COVID-19 is an extremely contagious virus that spreads easily through person-to-person contact. Federal and state authorities recommend social distancing as a means to prevent the spread of the virus. COVID-19 can lead to severe illness, personal injury, permanent disability, and death. Participating in MBJCC ECA programs or accessing the MBJCC facilities could increase the risk of contracting COVID-19. The MBJCC in no way warrants that COVID-19 infection will not occur through participation in MBJCC programs or through access to the Miami Beach JCC facilities, and on behalf of myself and my family members and minors, assume the risk of such illness, injury, disability and death in connection with COVID-19.

**WAIVER:** I understand that MBJCC ECA activities have inherent risks and hereby assume all risks and hazards inherent to my child's participation in all MBJCC ECA programs and facilities. I further release, absolve, indemnify, and agree to hold harmless the MBJCC ECA, the organizers, volunteers, supervisors, officers, directors, participants, coaches, referees, as well as persons or parents transporting participants to or from such activities from any claims or injury sustained during my child's use of MBJCC facilities or participation in any MBJCC ECA activity, whether located on MBJCC property or not.

**PUBLICITY:** The MBJCC ECA reserves the right to use photographs and/or videos of my child for publicity purposes in all media including the MBJCC website and all social media.

**PARKING LOT:** All vehicles parked in the MBJCC parking lot are parked at the vehicle owner's risk. MBJCC is released of any responsibility or liability for loss and/or damage to or by a vehicle while parked in the MBJCC parking lot, including but not limited to partial or total theft, collision, fire, weather and construction.
