By this time now, every person is familiar with COVID-19, also known as the Coronavirus. Our schools have been closed temporarily as an abundance of caution for the health and safety of our students and our staff. The Governor, Commissioner of Education, School Board and Superintendent have given us the mission to still provide education for students while at home during this crisis. The Superintendent has directed a model of distance learning where we will provide lessons through online platforms led by teachers who will communicate to your child and you.

Valencia Dual Enrollment Fall 2020 Applicants- The test score deadline has been extended to May 1st. Current Juniors may use their most recent SAT test scores if they meet the eligibility requirements. SAT scores can be sent from the Students College Board account directly to Valencia. Valencia is currently working on an alternate form of testing should students not be back on our or their campus to test prior to that date.

FOOD DISTRIBUTION

Grab-and-Go meals are available for pick-up between **10 a.m. and 1 p.m., Monday through Friday**, in the car loop at Edgewater HS. Students must be present to receive the meals, *EXCEPT ESE students*. District staff will distribute the meals directly to those in their vehicle (drive-thru service). Meals will be given directly to any students walking and/or riding a bike. Based on recommendations from our federal and state leaders, all meals should be taken home to eat. Parents of ESE students should tell the meal attendant of their child's inability to be with you and you will be served.

TESTING

Current seniors: If a senior is expected to graduate in spring of 2020 and has not met the exit criteria for Algebra I EOC and/or Grade 10 ELA FSA, or earned a concordant score, this criteria will be waived.

However, students still must earn the necessary credits and meet the GPA requirements to graduate.

Non-seniors: The Department is waiving the requirement for non-senior students who are currently enrolled in a course that requires an EOC to take the associated EOC. However, non-seniors who have yet to pass the Grade 10 FSA ELA must still meet the exit criteria by passing that assessment during a future administration or earning a concordant score. Though non-senior students enrolled in the EOC course of Algebra 1 are not required to take the Algebra 1 EOC, they must still meet the mathematics assessment graduation requirement by either passing the Algebra 1 EOC (offered four times each year) during a future administration, earning a concordant score, or passing the Geometry EOC during a future administration.

SAT: In response to the rapidly evolving situation around the coronavirus (COVID-19), College Board cancelled the May 2, 2020 SAT and SAT Subject Test administration. Students who already registered for May will receive refunds. The College Board will provide future additional SAT testing opportunities for students as soon as possible in place of canceled administrations and the next scheduled test is June 6, 2020. To help students keep their college readiness skills sharp when many schools are closed, College Board and Khan Academy will continue to provide [free resources online](#), including full-length practice tests and personalized learning tools. ACT: ACT has rescheduled its April 4 national test date to June 13 across the U.S. in response to concerns about the spread of the coronavirus (COVID-19). All students registered for the April 4 test date will receive an email from ACT in the next few days informing them of the postponement and instructions for free rescheduling to June 13 or a future national test date.
