<u>Eligibility:</u>

- Rent your home, apartment, or other residential dwelling in Florida.
- Behind at least one month late notice (text, email, letter, etc.)
- Household income not to exceed 80% AMI.
- Have qualified for unemployment, experienced a loss of income, incurred significant costs or financial hardships due to COVID-19.
- At risk of losing your home, experiencing housing instability, or are living in unsafe or unhealthy conditions.

What to Bring:

Valid ID: (any of the following or combination)

- Driver's license or State ID card
- U.S. birth certificate
- College ID
- U.S. Passport
- Military ID
- DHS issued immigration documents.

Rental Information:

- Current lease (signed, including the names of tenants, lease term, payment terms); OR
- Proof of rental arrangement, such as receipts, bank records or cancelled checks that show a pattern of rent payments.

Proof of Rental Arrears (past-due rents):

- Notice of late rents, eviction notice, or notice of court filing; OR
- Signed statement by landlord of pastdue rents

Income Documentation for ALL adult household members (18+) (all that apply):

- 2020 tax returns (IRS form 1040)
- Notice of SNAP, TANF, or Medicaid benefits
- Proof of unemployment benefit amount
- Proof of current income for the past 30+ days (4 weeks or 30 days of current pay stubs)

Income Documentation for ALL adult household members (18+) (all that apply):

- Unemployment documents
- Termination or layoff notice
- Notice of business closure
- Proof of wageS PRIOR to March 13, 2020 (at least 3 pay periods) to show reduction in income.
- Proof of loss of child or spousal support
- Employer statement of reduction of wages
- Receipts of purchased items related to COVID-19.

Risk of homelessness and/or housing instability:

- Notice of eviction dated on or after March 13, 2020
- Notice to vacate dated on or after March 13, 2020
- Past due utility notice
- Past due rent notice
- Current order of Protection for domestic or repeat violence.
- Bills for temporary residence in a hotel or motel

Proof of Utility arrears:

• Most recent utility bills.
