CONSTRUCTION CAREER CAMP
Liability Waiver and Release Agreement

As parent or legal guardian of _____ ("my daughter"), I request that the above named student be permitted to participate in the National Association of Women in Construction Chapter 73 ("NAWIC Chapter 73") Construction Career Camp ("CCC") scheduled for June 3-7, 2019 at Westside Tech. In consideration of my daughter's participation in this camp, and other valuable consideration, the receipt and sufficiency of which is acknowledged herein, I knowingly and voluntarily agree to the following:

I understand that, as a condition to participate, my daughter must present evidence of medical insurance and I hereby state that she is covered by such insurance. I agree that, in the event medical attention is necessary for my daughter, I hereby appoint the camp directors on my behalf, to arrange for medical care and transport (including first aid) at their direction and in their discretion. I agree to be solely responsible for any fees or costs incurred for transportation to and the medical treatment sought by NAWIC Chapter 73 CCC on my daughter's behalf. On behalf of my daughter, I hereby release and agree to indemnify and hold harmless NAWIC Chapter 73 CCC, its directors, volunteers, and instructors, for any and all such fees or costs incurred.

I understand that camp activities are intended to provide hands-on experience of a construction work environment. Activities include, but are not limited to: electrical wiring performed without power connections, fire protection, plumbing, tile setting, and carpentry exercises. I understand the activities involve foreseeable risks of illness or serious injury with or without the negligence of others. On behalf of my daughter, her heirs, representatives, administrators, executors, and assigns, I agree to incur and assume such risks as a condition of participation in the activities for which my daughter is registered.

On behalf of myself and my daughter, I intend to be legally bound and hereby waive all claims, releases and discharges, covenants not to sue, and agree to indemnify and hold harmless NAWIC Chapter 73 CCC, Orange Technical College - Westside Campus, Orange County Public Schools, their related entities, officers, directors, sponsors, guest instructors, camp directors, contractors, volunteers, attorneys, representatives, and agents (collectively, "Releasees") from any and all liability, loss, cost, expense, claims, demands, actions, judgments, which my daughter may sustain or suffer, for personal injuries or damage to property (real or personal), known or unknown, in any way caused by, related to, or arising from, directly or indirectly, participation in the Construction Career Camp or for any transportation to or medical treatment sought by NAWIC Chapter 73 on my daughter's behalf. I represent and agree that this waiver and release is binding not only on my daughter and myself, but also upon our respective heirs, representatives, administrators, executors, and assigns.

I further agree that if I or anyone acting on my or my daughter's behalf makes a claim against any of the Releasees despite this release and waiver, I shall indemnify and hold harmless, each

or any Release from any litigation expenses, attorney's fees, loss, liability, damages or cost any Release may incur as a result of or in connection with any such claim.

This Agreement shall inure to the benefit of the assigns, licensees, insurers, and legal representatives of NAWIC Chapter 73. Florida law shall govern this Agreement without regard to its conflicts of law provisions.

Objectives:

- ✓ Provide a supportive and nurturing environment for high school girls to explore and develop basic construction skills in a variety of areas
- ✓ Offer high school girls a gender neutral environment to learn and practice new skills

Camp Rules:

1. Safety

- ✓ The National Association of Women in Construction (NAWIC) consider safety a core principle of Construction Career Camp. Any camper that disregards the safety rule and procedures may be asked to leave the program immediately. Horseplay or misuse of equipment will not be tolerated.

2. Dress Code

- ✓ Campers must abide by the dress code of the construction industry: long pants, t-shirts or shirts, and close-toed shoes are required. Flip-flops, dangling jewelry or belts (or anything that can become caught in equipment) are prohibited.

3. Schedule/Transportation
