You will need to register for this ‘sub-event’ if you plan to participate. We will be staging a scavenger hunt for the students to get them to attend a lot of booths. There is nothing that you need to do for the scavenger hunt but you may choose to do virtual presentations on your company and positions or upload videos for students to view.



### **Steps to participating in the Fall 2020 Virtual Job Fair:**

1. Go to this link <https://www.nemojt.org/employers/> to register your business for the event.
2. Once you have registered with us, you will receive a link to Premier Virtual to register your company and set up a username and password. You will also receive links to view a training video on setting up your booth. According to Premier Virtual, setting up the booth should take about 30 minutes. **The deadline for setting up your booth is Friday October 16th.**

**Important:** We do not want you to miss out due to lack of experience with this technology so if you find that you need help with booth setup, Premier Virtual staff and our agency will be here to help.
