Remarks From the President at the 2020 TAM Conference

When I first moved to Texas from Massachusetts over five years ago, I didn't know anyone in the state, let alone any people who shared my passion. I just happened to meet a UT professor in the airport who put me in touch with Suzanne Schwartz, Susan Schultz, and Walter Wright. All torchbearers for mediation in this state.
