Dear Majority Leader Stewart-Cousins and Speaker Heastie,

New York Disability Advocates (NYDA) is the coalition of the six statewide provider associations representing not-for-profit intellectual and developmental disability (I/DD) provider agencies. Our agencies deliver essential supports and services to more than 85% of New Yorkers with I/DD. We respectfully request you support the Governor's automobile insurance reform proposals in the final enacted budget.

The crisis in New York's auto insurance market has hit I/DD providers particularly hard. New York drivers already pay among the highest auto insurance premiums in the nation, with full coverage averaging over \$4,000 per year per vehicle — nearly \$1,500 above the national average. Auto insurance costs have escalated significantly due in part to systemic inefficiencies and abuses within the no-fault system.

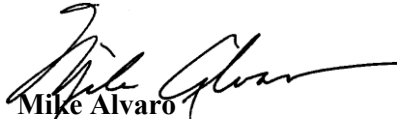
These increases place severe financial strain on nonprofit providers and divert limited Medicaid and state resources away from direct care and workforce investment. Unlike for-profit businesses, our providers cannot simply pass these costs on to consumers. As providers continue to operate on thin Medicaid reimbursement margins, these auto insurance premiums would otherwise go directly toward staffing, services, and programming.

Provider agencies maintain large fleets of vehicles to transport the people they serve across programs they operate. Daily transportation is essential in order to provide community-based supports. Continued escalation in premiums threatens the sustainability of these transportation systems and creates the risk of service reductions. Inclusion of the Governor's reforms in the final budget would provide necessary cost containment and predictability so providers can direct resources toward care delivery and workforce stability rather than uncontrollable insurance expenses.

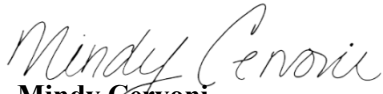
The Governor's proposal represents a balanced approach to modernizing the system while preserving protections for legitimately injured individuals. The proposed reforms address fraud and cost drivers, align reimbursement structures more closely with medical necessity, and introduce appropriate guardrails to stabilize the insurance market.
