About the Award: Employers across the state are acknowledging the value of employing people with intellectual and other developmental disabilities in their place of business. The Arc New York Employer Recognition Awards provide Chapters with an opportunity to recognize an individual, corporation or business in New York State that has demonstrated outstanding support in providing services and job opportunities for people who have intellectual or other developmental disabilities. Four (4) awards are presented annually.

Eligibility Criteria:

- The nominated business must not be owned, operated, or a subsidiary of a Chapter of The Arc New York
- The nominated business must employ people with intellectual or developmental disabilities
- Each Chapter may submit one (1) nomination

Application Requirements:

- Completed application, signed by Chapter Board President *or* Executive Director
- Letters of support may be included if desired

The Arc New York Employer Recognition Awards will be presented at the July 2021 virtual Board of Governors meeting.
