# 9th JURIED BIENNIAL Invitational

## **Who can submit?**

The Invitational is open to all artists residing in Mississippi or were born in Mississippi. All works must have been completed within the last two years.

## **How do I submit work?**

All entries will be judged based on digital images. The images must be at least 300 dpi. The file name must be the title of the work. Artists sending 3D work may submit 3 images of each piece entered. Entries may be submitted by mail or email. Maximum number of entries allowed for each artist is three (3) works.

## **To Mail:**

If you are submitting your entries by mail, please save them as .jpg files on a CD or thumb drive. The CD or thumb drive must be clearly labeled with name, title, dimensions, and medium; enclose the completed entry form and fee with your entries. Include a completed PDF version of your entry form. Mail your entry fee to the address above. Please note that your entry cannot be considered if your entry fee is not received.

## **What does it cost?**

Each artist must enclose a non-refundable entry fee of \$35.00. Make checks payable to the Greenville Arts Council.

## **What could I win?**

We are awarding one Best-of-Show purchase award of \$1500, two awards of \$500 each, and five \$100 merit awards.

**What can I submit?**

Paintings of all media, original prints, drawings, graphics, photographs, sculpture, wood-turned work, fiber arts, and ceramics may be entered. Accepted entries must not exceed 216” in total perimeter, including frame. They must be framed for exhibition and ready to hang/install. Sculpture must not exceed 72” in height or 48” in any other direction. Maximum weight limit is 100 lbs., and the base must be firmly attached. Hanging sculpture must not exceed 25 lbs. Works must arrive with labels securely attached to lower left corner on back or bottom of work.

**When will you let me know if I got into the exhibit?**

Notification of acceptance will be emailed and mailed by June 28, 2021. All shipped or hand-delivered work must arrive at the Greenville Arts Council by 4:00 on Friday, July 2. Shipped artwork must have prepaid return shipping labels included. Works must be packed in secure, reusable crates or boxes. Artists must pick up their hand-delivered works within 30 days after the end of the exhibit, or they will become the property of the Greenville Arts Council. As soon as possible, shipped works will be returned.

**What if my work is sold?!**

It could happen! In the event that an exhibited work is sold, the Greenville Arts Council will retain a 30% commission on the sales price, and a check will be issued to the artist at the conclusion of the exhibit.

**Who is the Juror?**

Rick Anderson of Clinton, MS is an award-winning professional artist, a retired visual arts instructor, and a children’s book illustrator and presenter. He is listed on the Mississippi Arts Commission’s Artist Roster. Rick’s artwork can be seen in galleries and private collections in Mississippi and throughout the USA.
