# What's News?



# Deadline Nears! 16 Days To Apply for Hurricane Ian Assistance

- Homeowners and renters in one of the 26 designated counties affected by Hurricane Ian have until Jan. **12, 2023**, to apply for FEMA individual assistance.
- The deadline to apply for low-interest disaster loans from the U.S. Small Business Administration is also Jan. 12, 2023.

# More Counties in Florida Now Eligible for FEMA Public Assistance for Hurricane Nicole

- Additional 51 counties affected by Hurricane Nicole are now eligible for Emergency protective measures, including direct federal assistance under the public assistance program. The Miccosukee Tribe of Indians of Florida and the Seminole Tribe of Florida are eligible as well.
- Houses of worship and other nonprofit organizations may also be eligible for FEMA public assistance.
- FEMA's public assistance program provides reimbursement to local and state government agencies for the costs of emergency response, debris removal and restoration of disaster damaged public facilities and infrastructure.

# SBA Offers Disaster Loans With No Interest, No Payments for First Year

- New disaster loan borrowers from Small Business Administration will now have up to one year from the date of the note to begin making payments. Interest will not begin to accrue until 12 months from the date of the initial loan disbursement.
- The deferment to 12 months is automatic. Borrowers do not need to take any additional action.
- There is no prepayment penalty if borrowers choose to make loan payments during the deferment period.

## Federal Support for Hurricane Ian Exceeds \$4 Billion





More than 4.4 billion in federal grants, disaster loans and flood insurance payments has been provided to the state of Florida and to households affected by Hurricane Ian.

# By the Numbers

#### **Numbers Related to Hurricane Ian:**

- \$4.4 billion in federal grants, disaster loans and flood insurance payments
- \$847 million in FEMA Individual Assistance approved for 365,726 households
- \$1.35 billion in U.S. Small Business Administration disaster loans approved

- 45,500 National Flood Insurance Program claims filed in Florida: \$1.72 billion paid
- \$496 million in FEMA Public Assistance approved for emergency response costs
- 1,616 households (3,930 members) checked into hotel rooms under FEMA's Transitional Sheltering Assistance for households
- 20,119 Blue Roofs installed by U.S. Army Corps of Engineers (Mission completed)

#### **Numbers Related to Hurricane Nicole:**

- \$ 1.27 million approved for FEMA Individual and Households Program to support Hurricane Nicole survivors
- 2,873 registrations received from survivors in designated counties affected by Hurricane Nicole
- 3,249 homes visited by FEMA teams working in neighborhoods affected by Hurricane Nicole
- \$958,000 approved in U.S. Small Business Administration disaster loans

#### **Volusia County Approved for Direct Temporary Housing Assistance for Hurricane Ian**

- Volusia County just joined the other six counties eligible for FEMA direct temporary housing under Hurricane Ian declaration DR-4673-FL.
- Hurricane Ian survivors in these seven counties can apply for direct temporary housing: Charlotte, Collier,
   DeSoto, Hardee, Lee, Sarasota and Volusia.
- This assistance includes direct lease of residential properties, repair of existing vacant multi-family properties for use by survivors, and travel trailers or manufactured housing units.

# How To Apply for FEMA Assistance If Your Primary Residence Is a Boat

If your primary residence is a boat, you may qualify for FEMA assistance. Please use the physical and complete address of the dock or marina and the slip or mooring number, if the boat was not located on private property.

# More Applicants Qualified as More Types of Documents Accepted

- FEMA now accepts more types of documents to verify ownership and occupancy, and also accepts documents from a wider range of dates.
- Additional 11,600 survivors of Hurricane Ian have received more than \$140 million in assistance that they
  otherwise would not have been eligible to get.

#### Disaster Recovery Centers Accessible to People with Disabilities

Disaster Recovery Centers are accessible to people with disabilities and those with access and functional needs.

- The centers have assistive technology equipment that allows survivors to interact with staff.
- Video Remote interpreting is available and in-person sign language available by request.
- Real-time captioning as well as information in Braille, large-print, audio and electronic versions are available.
- The centers also have accessible parking, ramps and restrooms.

## FEMA Mitigation Funds To Help Rebuild Stronger

Homeowners who are eligible for Individuals and Households Program assistance may receive additional mitigation funds from FEMA to reduce damage losses. Specific mitigation measures may include:

- Roof repair to withstand higher winds and help prevent water infiltration.
- Elevating a water heater or furnace to avoid future flood damage.
- Elevating or moving an electrical panel to avoid future flood damage.

# Additional Time To Renew Flood Insurance Policy

- Over 8,000 National Flood Insurance Program policyholders affected by Hurricane Ian in Florida may still be able to renew their policy due to the grace period extension. The renewal extension applies to people whose flood insurance policy expiration was between Aug. 25 and Oct. 23.
- NFIP has extended the grace period to renew policy from 30 days to 90 days for certain Florida policyholders in 26 counties where individual assistance has been authorized due to Hurricane Ian.

# **Protect Yourself From Identity Theft**

If a FEMA inspector visits your home but you have not applied for FEMA assistance, or if you receive a letter from FEMA without submitting your FEMA application, you may be a victim of identity theft. If so, please inform the FEMA inspector or call FEMA Helpline at 800-621-3362 to stop the application process. If you suspect identity theft, please visit Identity Theft | FTC Consumer Information or IdentityTheft.gov.

#### **Substantial Damage Determinations**

Local community officials are required to inspect disaster-damaged structures in Special Flood Hazard Areas to meet the requirements of the Florida Building Code and the community's floodplain management regulations. If the cost of repairing the structure to its condition before Hurricane Ian is 50 percent or more of its pre-disaster market value, the house or building is considered "substantially damaged." FEMA does not make substantial damage determinations; the determination is made by a community's building official or floodplain manager. Repairing a structure in a floodplain requires a permit. Survivors have options to bring the structure into compliance with the Florida Building Code and the community's floodplain management regulations.

# **Temporary Housing for Survivors**

FEMA is providing grants for basic repairs to homes damaged by the storm, rental assistance for those who can't remain in their homes and hotel stays for survivors who can't find a place to rent. This support is available in all 26 counties approved for FEMA Individual Assistance under the disaster declaration of Hurricane Ian.

## **Advance Payment in National Flooding Insurance Program**

- Contact your flooding insurance agent or company to see if you can receive an advance payment to help jumpstart your recovery.
- Policyholders of National Flooding Insurance Program affected by Hurricane Ian may receive \$5,000-\$20,000 with documentation, before an adjustor visits.
