

# 2024 CALL FOR NOMINATIONS FOR EMPLOYER OF THE YEAR

The Tri-County Workforce Investment Board is seeking nominations for employers in Armstrong, Butler, and Indiana Counties who have significantly contributed to workforce development within the region.

An **Employer of the Year Award** will be given to an employer in each of the three counties to highlight the collaboration of business and workforce investment in the three counties.

The deadline for nominations is **October 18, 2024**.

**Eligibility** – Nominees must be an employer located in Armstrong, Butler, or Indiana Counties.

**Nominations** – Nominations will be accepted from anyone within the community. **Employers are strongly encouraged to nominate themselves.** Previous winners may be nominated; however, **a company cannot win two years in a row.**

**Criteria** – Winners will be selected based on nominee efforts to support and utilize local workforce development.

**Judging** – Nominations will be reviewed by a committee of members of the Tri-County Workforce Development Board.

**Announcements** – Employers will be honored at the December 13, 2024 Workforce Investment Board Meeting. Winners will be notified prior to the meeting by email and a follow-up letter.
