Driving Under the Influence of Alcohol

At 8:25 p.m. an officer was responding to the area of 75th Street and Cass Avenue for a hit and run accident when the officer was advised of the location of the offending vehicle. The officer made contact with the driver, Aaron Phillips, 43, of the 6700 block of Sweetbriar Lane, Darien who was arrested for driving under the influence of alcohol, leaving the scene of an accident and operation of uninsured motor vehicle.
