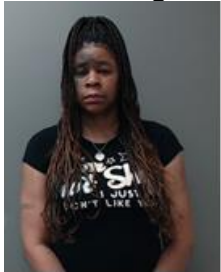

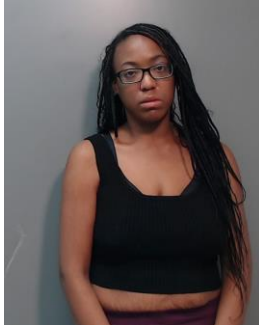
Driving Under the Influence of Alcohol
