Warrant Arrest

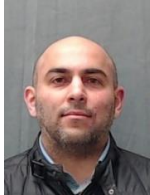

Driving Under the Influence of Alcohol

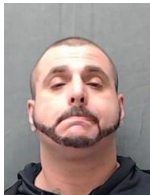

Driving While License Revoked

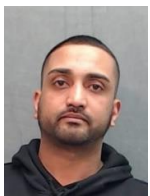

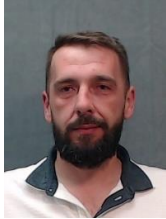
Domestic Battery

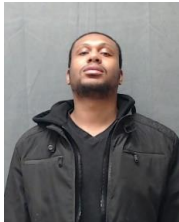
Driving Under the Influence of Alcohol

Fugitive from Justice

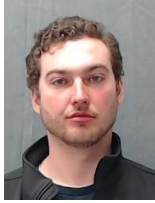
