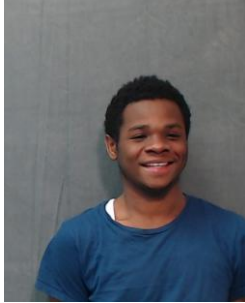

**Driving While License Suspended**

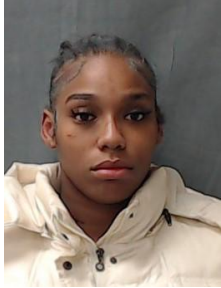
