MEETING: EVERY CLUB IN PFGC GETS A VOTE

BASED ON MEMBERSHIP AS OUTLINED BELOW. PFGC IS ACTUALLY MADE UP OF CLUBS/CIRCLES AND THE TITLE OF ‘FEDERATION’ WAS ‘GRANDFATHERED’

IN...EACH CLUB/CIRCLE SHOULD HAVE A SAY AND VOTE

ACCORDINGLY....IT WOULD BE UNFAIR FOR PFGC TO VOTE FOR THE CLUBS.

Clubs & Circles:

1. Membership 10-25: President or alternate (1)
2. Membership 26-50: President plus one (2)
3. Membership 51-75: President plus two (3)
4. Membership 76-100: President plus three (4)
5. Membership 101 to 125: President plus four (5)
6. Membership over 125: President plus four plus one for every additional 25 over 125.

Additional delegates when registering for District Meetings include: FFGC BOD Members living in District I (which includes FFGC Officers, FFGC Chairmen, and Former FFGC Presidents), District I Officers and Chairmen, and Former District I Directors.

Each person above is entitled to one (1) vote.
