



## Concord Area Watermain Replacement, Road Rehabilitation and Sidewalk Construction

To upgrade the infrastructure in your area, in mid-April 2020 the City of Vaughan will begin watermain replacement, new sidewalk construction and road rehabilitation to the streets listed below.

### CONSTRUCTION IMPACTS

Roads will remain open to vehicular and pedestrian traffic during construction. Temporary lane restrictions will be required to allow construction activities to proceed in a safe and efficient manner.

To minimize the overall impacts and duration of the project, components of the watermain, including water services, installation will be scheduled during evening and overnight hours.

Additional notices will be circulated at least 48 hours in advance of any water disruption to all impacted residents and businesses.

Access to private and commercial driveways and entrances will be impacted at times during the watermain replacement and associated restoration works. Work at the location of commercial entrances will be staged so that continued access is maintained during business hours.
