Dr. Archie Tucker II

Dr. Archie Tucker II currently serves as President of Push Pull Solutions (PPS), LLC, a woman-owned, minority-owned consulting firm specializing in external relations, government affairs, philanthropy, community engagement, executive strategy, fundraising, marketing, and organizational leadership development. PPS's service has included but has not been limited to leading national fundraising efforts, lending curriculum development expertise, and providing interim leadership at the Thurgood Marshall College Fund, UNCF, and Edward Waters University, respectively.

Archie brings more than 20 years of successful experience in higher education, with over half of his career spent in senior executive leadership roles reporting directly to institutional presidents. He has held executive leadership positions in development and external relations at four institutions across Mississippi, Alabama, Texas, and Florida. His professional expertise spans development, marketing, public relations, government affairs, economic and workforce development, negotiation, enrollment management, and career services.

Archie has served at both MSIs, including multiple HBCUs and an HSI, and a PWI, with more than a decade of service at Alabama A&M University. Most recently, he served as Senior Vice President of University Advancement at The University of Texas at Tyler, where he led development, alumni relations, community engagement, and special events across five academic campuses. His portfolio included fundraising for a new School of Medicine and advancement efforts across a 10-hospital, 90+ clinical healthcare system. Prior to UT Tyler, Archie served as Vice President for Marketing, Communication, and Advancement at Alabama A&M University. In this role, he oversaw fundraising; marketing, public relations, and brand engagement; a 100,000-watt radio station and television studio; The UPS Store; and other auxiliary and operational units. He previously served as the Chief Development Officer at Mississippi Valley State University and held

leadership and support roles in workforce development, career services, and enrollment management at Coahoma Community College and Delta State University.

Archie holds a Doctorate in Urban Higher Education from Jackson State University, an MBA from Delta State University, and a Bachelor of Business Administration from Mississippi Valley State University. He has completed executive education and certification programs through the Association of Governing Boards; the American Association of State Colleges and Universities and Association of Public and Land-grant Universities; the Higher Education Leadership Foundation; Harvard University; Indiana University; Hampton University; and The Lobby School. In 2015, he was named the inaugural Fundraiser of the Year by the Association of Fundraising Professionals - North Alabama.

Archie has served numerous boards and committees at the local, state, national, and international levels, with a focus on economic development, education, philanthropy, business and industry, and social justice. He is an active member of Sigma Pi Phi Fraternity and Alpha Phi Alpha Fraternity, Inc.

A native of Leland, Mississippi, Archie and his wife, Veronica, were featured on Season 3 of Ellen's Game of Games in 2020. They are the proud parents of two sons, Jordan and Austin.
