MAYOR LYDA KREWSON

In April 2017, Lyda Krewson won a historic election to become the first woman to serve as mayor of St. Louis. Prior to the election, Krewson served as 28th Ward Alderwoman. She is also a CPA and served as the CFO for an international design firm until her election as Mayor in 2017.

As Mayor, Krewson has focused intently on public safety, naming Judge Jimmie Edwards as Director of Public Safety and John Hayden as Chief of Police. She also led the effort to pass Proposition P, a half cent sales tax to provide salary and benefit increases for police and firefighters, and a million each for summer jobs, recreation for kids, mental health, and demolition. Krewson is also focused on reducing vacant buildings, cleaning up St. Louis, increasing economic and workforce development, and providing good service to all St. Louis residents, businesses and visitors.

Krewson is known for her civility, determination and fairness in addressing issues.

During her tenure as 28th Ward Alderwoman, Krewson unapologetically took on tough and controversial issues including passing the comprehensive smoking ban, fighting for common sense gun regulation, leading the effort to reduce the Board of Aldermen from 28 to 14, and passing the city's Prescription Drug Monitoring Program. Krewson worked closely with Forest Park Forever to renovate Forest Park, and with developers to bring responsible development to the Central West End, Skinker DeBaliviere, and the Loop. She is also known for making neighborhoods more accessible for walkers and bike riders, planting over 1,500 trees, sponsoring the "doggie dining" bill, and spearheading the Sunflower + Program.

After graduating with an education degree from Truman State University, Krewson moved to St. Louis where she earned her accounting degree from the University of Missouri-St. Louis. Later she worked for Deloitte for 7 years.

In 1998, she married Mike Owens. Today, they enjoy neighborhood walks, gardening, and occasional hikes in the mountains.

DR. BLANCHE TOUHILL

Blanche M. Touhill is Chancellor Emeritus and Professor Emeritus of History and Education at the University of Missouri-St. Louis. With nearly 17,000 students, UMSL is the third largest university in Missouri and the only public research university in the St. Louis metropolitan region.

Touhill served as chancellor at UMSL for more than 12 years. She was named interim chancellor in 1990 and appointed chancellor in April 1991. She retired on Dec. 31, 2002.

During her tenure as chancellor, UMSL added 30 academic programs, 32 endowed professors, 138 acres and several new buildings, including a \$10 million student-housing complex, \$32 million student center and \$52 million performing arts center that bears her name.

Touhill's commitment to collaboration and diversity earned her recognition from the Urban League, the Ethical Society, Dr. Martin Luther King Jr. State Celebrations Commission and the Conference of Christians and Jews. In 1997, Touhill became the first woman to receive the St. Louis Citizen of the Year Award.

Born in St. Louis in July 1931, Touhill began her career in education at Queens College, City University of New York. She joined UMSL as an assistant professor in 1965 and became a full professor in 1983.

In addition to her teaching duties, Touhill assumed administrative duties as associate dean of faculties in 1974 and associate vice chancellor for academic affairs two years later. She was named vice chancellor for academic affairs in 1987 and served in that role until moving to the Chancellor's Office.

Touhill holds bachelor's and doctoral degrees in history and a master's degree in geography -- all from Saint Louis University. Her areas of expertise include 19th century Irish and Australian history and social studies education. She has published four books, including *The Emerging University: The University of Missouri-St. Louis, 1963-1983*, and numerous other articles and writings.

KITTY RATCLIFFE (GROVER)

Kathleen Ratcliffe is the president of Explore St. Louis, responsible for the sales and marketing of St. Louis as a destination for visitors and the operations of both the Convention Center and The Dome at America's Center. She is the only woman in the country running the operations of all three entities and has been doing so for more than a dozen years.

Kitty is a past international Chairwoman of Meeting Professionals International (MPI), the largest global association of meeting professionals, and is a recipient of their International Supplier of the Year Award. She serves on the board of the Professional Convention Management Association and has co-chaired PCMA's annual convention, Convening Leaders, the annual gathering focused on education for the business events industry. She has received the Destinations International's Leadership in Environmentally Responsible Tourism award and in 2019 was inducted into their Hall of Fame for significant contributions to tourism and shaping the future of destination marketing.

In 2018 she received the Apex Award from Black Meetings & Tourism, and has been named as one of the Most Influential Businesswomen in St. Louis by the St. Louis Business Journal, as well as a Leader of Distinction by the YWCA of Metro St. Louis, a Regional Leadership Award from the St. Louis Community Empowerment Foundation and an Athena Award from the Hellenic Spirit Foundation.

Dedicated to growing and strengthening the economy of the St. Louis region through tourism development, she believes that St. Louis is a community on the rise.

JACKIE JOYNER-KERSEE

One of the most decorated female athletes of all-time.

Jackie dominated the track and field circuit for over 20 years and won three gold, one silver and two bronze medals spanning four Olympic Games during her illustrious career.

Jackie received the Jesse Owens Award in both 1986 and 1987. She still holds the world record in the heptathlon (7291 points) and is the American record holder in both the heptathlon and long jump (24-7). On December 3, 2004, she was inducted into the U.S. Track and Field Hall of Fame.

The inaugural recipient of the Humanitarian Athlete of the Year, Jackie is known worldwide for her interest in aiding others. She has helped to build the Jackie Joyner-Kersey Youth Center Foundation in her hometown of East St. Louis, Ill., that has raised more than \$12 million.

In 2007, along with several notable athletes, she founded Athletes for Hope, a charitable organization of professional athletes who get involved in charitable causes and inspire millions of non-athletes to volunteer and support their community.

In 2010, Jackie was honored with an NCAA Silver Anniversary Award given each year by the American National Collegiate Athletic Association (NCAA) to recognize six distinguished former student-athletes on their 25th anniversary as college graduates. Most recently, Jackie was selected as the recipient of the 2011 Dick Enberg Award. The Award is presented annually to a person whose actions and commitment have furthered the meaning and reach of the Academic All-America® Teams Program and/or the student-athlete while promoting the values of education and academics.

Jackie received the Stan Musial Lifetime Achievement Award from the St. Louis Sports Commission in 2017. The Stan Musial Lifetime Achievement Award is the pinnacle honor bestowed at the Musial Awards and the highest award for sportsmanship. It recognizes iconic sports figures who exemplify sportsmanship and embody the class, dignity, generosity, excellence, civility and integrity synonymous with Stan The Man.

She also served as the first female President and Vice President of the National Congress of State Games, Vice President of The Jackie Joyner-Kersey Foundation, Chairwoman of the Bob Emig Foundation and a board member of the Cardinal Glennon Hospital Foundation. Moore was named a 2016 “Woman of Distinction” of the Missouri Athletic Club. Maureen and her husband, Michael founded Saddleback Stables in 2001, a thoroughbred breeding and racing venture. They have two sons, Patrick and Kyle.

ADRIENNE DAVIS

Adrienne Davis holds appointments at Washington University in St. Louis as the William M. Van Cleave Professor of Law; Vice Provost; and the founding Director of the Center for the Study of Race, Ethnicity & Equity, a new center that brings the research force of Washington University to study how race and ethnicity are integral to the most complex and challenging issues of our time.

Davis's academic teaching and research focus on what she calls "the law of daily life," including Property, Contracts, and Trusts & Estates. She also brings that lens to bear on the legal history of

American slavery as well contemporary issues in gender and racial equality. Her work has been published in the Stanford Law Review, Columbia Law Review, and California Law Review, and she has been the recipient of a Bellagio Fellowship from the Rockefeller Foundation and a grant from the Eli Lilly Foundation to support a collaboration between Washington University's medical school and Meharry Medical College.

As Vice Provost, she works for the University's chief academic officer on a suite of initiatives to support faculty hiring, retention, and development, as well as designing infrastructure to support students. In fall 2017 Davis was recognized with a Washington University Founders Day Distinguished Faculty Award.

Outside of work, Davis is passionate about the arts and St. Louis and embraces opportunities to combine her two loves. Davis served for three years as the President of the Board of Trustees of the St. Louis Art Museum; currently, she is the Secretary to the Art Museum's Board of Commissioners. She is also a member of the boards of Opera Theatre St. Louis, Our Little Haven, december literary magazine, Fashion Fund St. Louis, and the St. Louis Visionary Awards. She served on the Board for Laumeier Sculpture Park for seven years and chaired their Executive Director search in 2017. In 2017 Davis was honored as a St. Louis Woman of Achievement for Arts Advocacy.

THERESA CARRINGTON

Growing up in poverty in the Midwest, Theresa drew upon her life experiences to innovative approaches to ending poverty. Fifteen years later, Theresa and her team have discovered a formula which sustainably ends poverty. This formula has been successfully replicated in 8 developing nations, reignited more than 65 local economies across three continents and positively impacted the lives of more than 8,000 people and 32,000 of their family members.

Theresa was inspired to start her organization after experiencing a life-altering crisis. Friends, family, and strangers showered her with cards and letters of support. Placing the cards in a basket, Theresa returned

to the basket daily reading the cards and letters, finding strength to face the next day. Calling it her “Blessing Basket” Theresa began speaking to women’s group about overcoming struggle, and as women wanted to purchase one of their own, The Blessing Basket Project® was born. The objective, help artisans sustainably exit extreme poverty.

Over the past 15 years, Theresa and her team discovered the tipping point from extreme poverty to prosperity came when an artisan sold ten products a month at Prosperity Wages for three years. In 2018 The Blessing Basket Project changed its name change to Ten by Three®, the formula Theresa and her team discovered which ends poverty.

In 2016 Ten by Three was one of only 10 Non-Profits in the world honored by the United Nations for the innovative way the organization brings cultures together through its Artisan&You® platform. Artisan&You is the world’s largest artisan engagement platform and allows consumers to connect with the artisan who made their products.

To date, the organization has created more than 300,000 human connection opportunities and thousands of letters have been exchanged between customers and artisans. Among her honors, in 2008 Theresa received the prestigious St. Louis Award. In 2013, she was named one of the St. Louis Business Journal’s Most Influential Business Women and YWCA Nonprofit Leader of Distinction. By 2015 Theresa was listed as 1 of 100 Most Influential women by Empowering a Billion Women By 2020.

BETHANY JOHNSON-JAVOIS

As CEO of the St. Louis Integrated Health Network (IHN), Ms. Johnson-Javois leads a \$2.5 million non-profit that serves the region's safety net health care providers and the local community to promote the mission of providing quality, affordable, accessible care to all residents of Metropolitan St. Louis, with an emphasis on the medically underserved. Her leadership in the healthcare sector has garnered notable recognition including being selected by Mental Health America of Eastern Missouri as a 2016 Silver Bell Award recipient for her outstanding community service, leadership, vision and values, and being selected as St. Louis Children's Hospital 2015 Community Advocate of the Year. She was also selected by the St. Louis Business Journal

2015 Class Diverse Business Leaders and received the Access to Equal Justice Award from the Washington University School of Law's Clinical Education Program. Under her leadership, the IHN was chosen as the St. Louis American's Advocacy Organization of the Year.

She possesses over 15 years of experience working and volunteering in the non-profit sector for organizations that positively impact the quality of life for disadvantaged populations. Her expertise lies in developing strategies to transform systems to be more responsive and equitable for the people for whom our public systems are accountable to serve. She currently serves on the board for Missouri Foundation for Health, chairs the board of Alive and Well Communities, LLC, and is former Trustee for the Deaconess Foundation and former member of the Executive Advisory Council for Missouri State University College of Business. As a licensed Evangelist Missionary in the Church of God in Christ, she holds numerous leadership roles and is a motivational speaker, trainer, and facilitator around spiritual development and leadership.

Notably, Ms. Johnson-Javois was named the Managing Director for the Ferguson Commission. The Ferguson Commission, an independent, volunteer group appointed by Missouri Governor Jay Nixon, was charged with addressing the underlying root causes that led to the unrest in the wake of Michael Brown's death. After a comprehensive study that included extensive community engagement, the Commission published an unflinching report of its findings and 189 calls to action that chart a new path toward healing and positive change for the residents of the St. Louis region.

Blake Strode is the Executive Director of ArchCity Defenders, a nonprofit civil rights law firm in St. Louis, Missouri providing holistic legal advocacy and combating the criminalization of poverty and state violence against poor people and people of color. Blake is a native of the St. Louis region and joined ArchCity as a Skadden Fellow and Staff Attorney following his graduation from Harvard Law School in 2015. Blake attended the University of Arkansas and majored in International Economics and Spanish. Blake helped to establish the Civil Rights Litigation unit at ArchCity, which has brought challenges to a variety of unlawful and predatory practices including debtors' prisons, police misconduct, and inhumane jail conditions, among others.

In the past few years, Blake and his colleagues have filed more than 50 civil rights cases in state and federal court, impacting upwards of 40,000 people in the St. Louis region. Blake also played a significant role in the class-action debtors' prison case against the City of Jennings, Missouri that reached final settlement in December 2016. The landmark case provides a blueprint for permanent legal reform in the region's courts and afforded monetary relief to hundreds of individuals who were jailed because of their inability to pay court debts.

Blake has spoken at conferences and panels throughout the country and recently authored multiple columns and essays for national publications on issues of race, policing, and criminal justice, including coauthoring "Debtors' Prison in 21st-Century America," which appeared in *The Atlantic* in February of 2016

DR. PETER WYSE JACKSON

Peter Wyse Jackson is the president of the Missouri Botanical Garden and George Engelmann Professor of Botany at Washington University in St. Louis, MO. Born in Kilkenny, Ireland, Wyse Jackson obtained a B.A. (Mod.) in botany and an M.A. from Trinity College Dublin, where he subsequently obtained a Ph.D. for work on the taxonomy of Irish Cruciferae.

As one of the world's foremost and best known botanists and plant conservationists, Wyse Jackson has played an influential role in reshaping and leading the international botanic garden community over the past two decades. He has worked extensively with botanic gardens and their network organizations worldwide, helping to establish or develop botanic gardens and other organizations in over 30 countries. He played a lead role in the development and implementation of the Global Strategy for Plant Conservation, adopted by the U.N. Convention on Biological Diversity in 2002, and has been chairman of the Global Partnership for Plant Conservation since 2004. He was co-author of the International Agenda for Botanic Gardens in Conservation, now endorsed by some 500 botanic gardens.

Wyse Jackson has been a member of the boards of numerous botanical, conservation and horticultural organizations around the world. He was founding chairman (and currently continues as co-chair) of the World Flora Online Consortium, an organization launched in 2012 to prepare an online Flora of the world by 2020. In 1995, he founded the European Botanic Gardens Consortium, an organization that links botanic gardens through Europe.

In St. Louis, he is a member of the Board of Trustees of the Donald Danforth Plant Science Center, a member of the Board of Commissioners of Tower Grove Park, a member of the Board of Webster University, an Ex Officio Trustee of the Academy of Science St. Louis and an ex officio member of the St. Louis Regional Chamber. He is an honorary member of the St Louis and Ladue Garden Clubs.

His publications include twelve books and over 250 scientific papers and other articles.

DR. SAMUEL ACHILEFU

Dr. Samuel Achilefu is the Michel M. Ter-Pogossian Professor of Radiology and Vice Chair for Innovation and Entrepreneurship at the Mallinckrodt Institute of Radiology, Washington University School of Medicine. He holds joint appointments as a professor of Medicine, Biochemistry & Molecular Biophysics, and Biomedical Engineering. He currently serves the Director of the Washington University Molecular Imaging Center and the privately funded Theranostic Innovation Program. He is co-Director of the Center for Multiple Myeloma Nanotherapy and co-Leader of the Oncologic Imaging Program of the Siteman Cancer Center at Washington University.

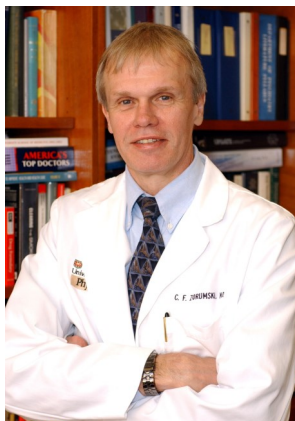
Dr. Achilefu is a fellow of the National Academy of Inventors as well as many professional societies, including the Royal Society of Chemistry, American Association for the Advancement of Science, the Optical Society of America, the International Society for Optics and Photonics Engineers (SPIE), the American Institute for Medical and Biological Engineering, and the St. Louis Academy of Science. He was a member of the College of Reviewers for the National Institutes of Health (NIH) and serves as member and chair of review panels for the NIH and the Department of Defense (DoD).

Dr. Achilefu is a world renowned expert in the development and use of light-sensitive drugs for cancer detection, imaging, and therapy. Recently, he conceived and led the development of a novel wearable cancer viewing goggles for the accurate removal of cancer cells during surgery. He also discovered a novel treatment paradigm for cancer using a special type of light and non-pharmacological doses of drugs to selectively trigger cancer cell death without harming healthy tissue. These and many other innovations have resulted in 59 US issued patents and over 300 scientific papers.

Dr. Achilefu has received over 30 local, national, and international honors and awards, including the prestigious Britton Chance Biomedical Optics Award in 2019 (SPIE), Distinguished Investigator Award in 2018 (Academy for Radiology & Biomedical Imaging Research), the Carl and Gerty Cori Faculty Achievement Award in 2018 (Washington University), Excellence in Healthcare Award in 2017 (St. Louis American), the first Department of Defense Distinguished Investigator Award in 2016 (DoD Breast Cancer Research Program), the St. Louis Award in 2014 (St. Louis Award Committee), and many others.

DR. CHARLES ZORUMSKI

Dr. Zorumski is the Samuel B. Guze (Goo-ZAY) Professor and Head of the Department of Psychiatry and Professor of Neuroscience at Washington University School of Medicine in St. Louis. Dr. Zorumski is also Psychiatrist-in-Chief at Barnes-Jewish Hospital and Director of the Taylor Family Institute for Innovative Psychiatric Research. Dr. Zorumski's laboratory studies synaptic transmission in the hippocampus. His studies focus on short- and long-term modulation of the glutamate and GABA neurotransmitter systems, with emphasis on how these transmitter systems participate in memory and neuropsychiatric illnesses. A long-standing interest concerns the mechanisms by which neurosteroids and oxysterols modulate GABA and glutamate receptors. Clinically, Dr. Zorumski is interested in the treatment of refractory mood disorders. He has published more than 320 scientific papers and holds five patents. His work has been continuously funded by the National Institutes of Health since 1987.

Dr. Zorumski was named Head of the Washington University Department of Psychiatry in 1997 and Samuel B. Guze Professor in 1998. Since 1997, he has served on the Steering Committees of the McDonnell Center for Cellular and Molecular Neurobiology and the McDonnell Center for Systems Neuroscience, and was Director of the Center for Cellular and Molecular Neurobiology from 2002 to 2013. Dr. Zorumski was named founding Director of the Taylor Family Institute in 2012. In 2015, Dr. Zorumski became Chair of the Oversight Committee for the Center for Brain Research in Mood Disorders. He serves on the Editorial Boards of JAMA Psychiatry and Cerebrum, and served on the Board of Scientific Counselors for the NIMH Intramural Research Program from 2009 to 2013. Dr. Zorumski is a distinguished fellow of the American Psychiatric Association, and a fellow of the American College of Neuropsychopharmacology and the American Psychopathological Association. Dr. Zorumski was elected to the National Academy of Medicine (Institute of Medicine) in 2012 and previously served on the Academy's Forum on Neuroscience and Nervous System Disorders. Since 2011, he has also served on the Scientific Advisory Board of Sage Therapeutics, a publically-traded company developing neurosteroids and oxysterols as treatments for neuropsychiatric illnesses.

these, Susan conceptualized and developed the St. Louis Chess Club and served as the founding executive director of the World Chess Hall of Fame, where she created the innovative exhibit A Queen Within which is still touring internationally. And in 2004, she implemented the Cross-Country art project for the Metro Transit's Arts in Transit program.

She currently sits on the executive board of the Contemporary Art Museum St. Louis and the board of the St. Louis Fashion Fund. She has served on the boards of Sheldon Art Galleries, Laumeier Sculpture Park, White Flag Projects, Arts in Transit, Landmarks Association, Southside School, the Hip Hop Chess Federation, the St. Louis Chess Club and the Airport Arts Commission.

Susan Sherman is Chair Emeritus of the Saint Louis Fashion Fund, a non-profit which enriches St. Louis through the business of fashion. Located in the heart of the Garment District, at 1533 Washington Avenue, the Fund supports emerging designers, provides education to high school students interested in careers in fashion and design, and works with the City of St. Louis on the redevelopment of the old Garment District in downtown St. Louis.

Sherman is also Co-Founder of MERCH, an experiential retail concept, which was launched in April 2019. MERCH brings intriguing global brands in fashion, beauty and home to St. Louis, and hopes to expand to other cities in the near future.

Sherman worked for over 30 years in public relations, special events and fundraising, in Atlanta, New York, and Paris before moving to St. Louis in 1993. PHIL WOODMORE

Saint Louis native, Phil Woodmore has been an active member of the St. Louis music community for many years. Phil received his bachelors from Saint Louis University in Business Marketing and Music Vocal Performance and then went on to receive his masters from Webster University in Music Education.

He is currently in the final stages of his PhD in Music Education at the University of Missouri-Columbia and is currently writing his dissertation on the transformative power of the music in the production, *Antigone in Ferguson* and how the choir is affected by the music in the process of learning and performing the show. Phil taught choir one year at Ferguson and Berkley Middle Schools in the Ferguson-Florissant School District and then went on to become the choir director at Crestview Middle School in the Rockwood School District where he taught for twelve years to over 3,000 students. Along with his work in Rockwood, Phil was the Coordinator of the Voice Program at the Center of Creative Arts (COCA) and the artist director of the Allegro Music Company from 2008-2017, he is the director of the Saint Louis Metropolitan Police Department Choir, was the director of the Northern Arizona University Gospel Choir from 2014-2017, Artist in Residency for the State of Arizona for a two year term 2016-2018, minister of music at Trinity Community Church, and vocal coach to many in the St. Louis and New York.

In August 2016 Phil was asked to compose an original score of a version of *Antigone* translated by Bryan Doerries called *Antigone in Ferguson* which has been traveling the country for the past three years and premiered in Athens, Greece in the summer of 2017. Since the success of *Antigone in Ferguson*, Phil has written an original score for Dr. Martin Luther King's last sermon *The Drum Major Instinct* and also for a speech by Frederick Douglass. During the summer of 2018, *The Drum Major Instinct* premiered in Athens, Greece and was performed on several college campuses during the 2018-2019 school year. In 2018, *Antigone in Ferguson* ran in an Off-Broadway theater in New York for a five-week workshop and this summer ran in New York for ten-weeks at the St. Ann and Holy Trinity Episcopal Church in Brooklyn.



The Phil Woodmore Singers assembled in 2017 after Artist Director of Theater of War Company, Bryan Doerries commissioned Phil Woodmore to compose musical selections for *Antigone in Ferguson*, a show based on a new translation of the classic Greek play, which premiered in Saint Louis, MO on September 17, 2016.

The choir is comprised of members of the Saint Louis Metropolitan Police Department Choir, Trinity Community Church Choir, students from the Center of Creative Arts (COCA) in University City, as well as singers from the greater Saint Louis community. Four talented musicians accompany the choir: Sergeant Ja'Mes Davis on saxophone, Assistant Chief of Police Jason Davis on keyboard, Bernard Long Jr. on drums, and Pastor Willie D. Woodmore on guitar.

Phil Woodmore, a Saint Louis native, has been directing choirs for the past twenty years and is grateful for the opportunity to direct the Phil Woodmore Singers. Since the premiere of *Antigone in Ferguson*, the choir has performed at the Onassis Center in New York, New York; the PopTech Conference in Camden, Maine; Coppin State University in Baltimore, Maryland; the BRIC organization in Brooklyn, New York; Dartmouth College in Hanover, New Hampshire; Williams College in Williamstown, Massachusetts; and Holy Cross College in Worcester, Massachusetts.

The Phil Woodmore Singers made their national television debut in 2017 at the Veiled Prophet Parade on July 1st. The group performed in the opening number, sang on a float presentation and performed an original arrangement of *America the Beautiful* written by director Phil Woodmore during the finale. In June 2017 the Phil Woodmore Singers had the honor of traveling to Greece for an *Antigone in Ferguson* workshop and performance followed by a performance in Brooklyn, New York July 2017. In June of 2018 the Phil Woodmore Singers traveled back to Athens, Greece to perform Phil's second project with the Theater of War Company, *The Drum Major Instinct*, for its international debut. Follow two successful trips to Greece, the Phil Woodmore Singers were honored to be invited to perform in *Antigone in Ferguson's* Off-Broadway run at the Harlem Stage in the fall of 2018 and at the St. Ann and Holy Trinity Church for a ten-week run in Brooklyn in 2019.
