### **#CLOSErikers**

On Thursday, September 5, the New York City Council held hearings about a plan to close the jail complex on Rikers Island and replace it with borough-based jails. The [#CLOSErikers plan](#) will shrink the jail system, improve conditions for any who is still detained, and invest in communities. The City Council vote is expected to come in October. That means we have time to contact our [City Councilmembers](#) about this important issue by email or by phone or in person.

### **PEACE & GLOBAL WITNESS OFFERING**

One of the five Special Offerings of the Presbyterian Church U.S.A.), the [Peace & Global Witness Offering](#) enables the church to promote the Peace of Christ by addressing systems of conflict and injustice across the world. Individual congregations are encouraged to utilize up to 25% of this Offering to connect with the global witness of Christ's peace. The Presbytery of New York City receives 25% for ministries of peace and reconciliation. The remaining 50% is used by the Presbyterian Mission Agency to advocate for peace and justice in cultures of violence, including our own, through collaborative projects of education and Christian witness. Sessions approve receiving the Peace & Global Witness Offering. If your congregation needs ideas for how to use it portion of the offering, the Justice Ministries Committee suggests contributions to support the work of the committee (make your gift to the Presbytery of New York City and designate it for the Justice Ministries Committee) or one of the organizations the committee works with: [JustLeadershipUSA](#) on ending mass incarceration, the [New Sanctuary Coalition](#) on issues of migration, or the [Interfaith Assembly on Homelessness and Housing](#) on issues of housing.
