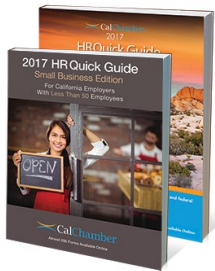

2018 CALIFORNIA & FEDERAL EMPLOYMENT POSTER

ALL required employer notices on one poster. Includes checklist to ensure poster is displayed according to the law. You must post a compliant *Employment Poster* in a conspicuous place in the workplace where all employees and applicants can see it. The poster also must include information about your workers' compensation benefits, payday schedule and emergency contacts. You may need to order several to ensure that your business, branches and satellite offices are displaying the poster according to the law. Failure to comply can result in severe penalties and fines by the state of California. ***If any of your company's workers are Spanish-speaking, you will need to order the Spanish version.***

Protect Yourself With 'Poster Protect'! *California Chamber will automatically replace your poster if any mandatory changes to your poster occur during the calendar year 2018. There is no additional shipping, handling, or tax for the new poster. Poster Protect must be purchased when posters are purchased.*



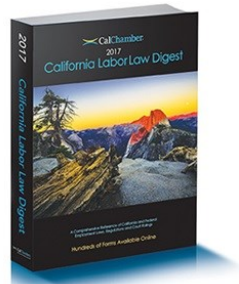
