Congressional Update

House and Senate on August Recess; Senate returns 9/6; House 9/13.

Congress largely focused on wrapping up Appropriations Bills and likely a Continuing Resolution to keep government operating beyond end of FY 9/30. Then home to campaign for mid-terms.

Lame Duck session expected in November/December to wrap up.

CRT Advocacy & News

Medicare Coverage of Power Seat Elevation and Power Standing Systems

- CMS has finally opened “public comment period” regarding Medicare coverage request
- Unfortunately, they are segregating the two technologies:
 - Seeking comments on **power seat elevation systems** now; **comments due by 9/14**
 - Will consider coverage of **power standing systems** at “a later date”

CRT News (cont'd)

Medicare Coverage of Power Seat Elevation and Power Standing Systems (cont'd)

- Dedicated advocacy website available at www.rise4access.org
- Important to generate as many supportive comments as possible for power seat elevation by 9/14- PLEASE SPREAD THE WORD AND WEBSITE
- Is it medical equipment? Should Medicare cover?
- The ITEM Coalition and stakeholders are following up with Congressional Champions and CMS to get power standing coverage request moving

CRT News (cont'd)

Continued Pandemic Challenges for Manufacturers/Providers

- Supply chain issues- backlogs and delays in obtaining products and parts
- Increased raw material and finished product costs
- Increased freight and distribution costs (shipping, gas prices) |
- Labor shortages and increased payroll costs
- CRT systems can consist of many components from different manufacturers; one delayed item can hold everything up
- Unlike typical business, providers cannot raise their prices; they are tied to fixed fee schedules

CRT News (cont'd)

Permanent Telehealth After Public Health Emergency

- Multiple conversations within Congress
- Legislation passed to extend for 151 days after PHE; more permanency is needed
- Coordinating our work with broader work of APTA, AOTA, and ASHA

CMS Seeks Input on Medicare Advantage Plans

- Search CMS-4203-NC for CMS request
- Looking for information on various aspects of Medicare Advantage program
- Great opportunity to provide feedback on significant problems that need to be fixed
- NCART Workgroup developing comments for submission on CRT access issues
- Comments due 8/31/22

CRT News (cont'd)

Extension of COVID-19 Public Health Emergency

- Broad federal and state implications when Public Health Emergency (PHE) expires
- Major concerns at state level due to end of certain Medicaid waivers and related funding
- Currently extended to 10/15/22
- Varied predictions when declaration will end; likely early 2023
- HHS Secretary Becerra will give stakeholders at least 60 days advance notice


