



UPDATE 1 – THE ADDITION OF TWO PERMANENT COMMITTEES

ARTICLE X

Standing Committees

SECTION 3: COMMUNICATIONS COMMITTEE

- A. The committee shall be composed of at least three people.
- B. Duties
 - I To provide support to church staff, committees, and ministries to develop, implement, and maintain a dynamic communications system that supports the church mission and strategy plans.
 - II Oversight over weekly newsletters, social media platforms, online social gatherings, newspaper columns, advertising, website, and livestream.
 - III To make budget recommendations to the Financial Committee.
- C. The Chair shall be elected by the committee.

SECTION 4: DEVELOPMENT COMMITTEE

A. The Development Committee will be composed of three to seven people, appointed by the Church President. Additionally, the Stewardship Committee Chairperson will serve as an ex-officio member. The Chair shall be nominated by the Nominating Committee and elected by the membership of the Church. The Chair will serve as a member of the Board of Directors

B. Duties

- To formulate, implement and coordinate the overall strategy for Church fundraising and endowment programs, including: special project needs, major gifts, and endowments, with the exception of the annual stewardship campaign, which will be managed by the Stewardship Committee. This will be done in close coordination with the Financial Committee.
- II To work closely with the Pastor and Board of Directors in coordinating Stowe Community Church's ("SCC") fundraising; this includes securing gifts for inclusion in the Stowe Steeple Society endowment, special purpose gifts, and major gifts (\$10,000 and above).
- III To educate Members and friends of the Church about how endowment funds and specific special and major gifts fulfill and enrich SCC's mission. It will develop and implement varied gift vehicles that can be used to accomplish the mission and other objectives of the Church.
- IV To coordinate and work closely with the Church Secretary and Treasurer to ensure that all necessary donor acknowledgments are sent in a timely manner.

ARTICLE VIII

Officers and Terms of Office

SECTION 5: CHAIR OF DEVELOPMENT COMMITTEE

The Chair of the Development Committee shall hold office for three years and is elected by ballot, voice vote, or a show of hands at the Annual Meeting.

UPDATE 3 – ADDING THE CHAIRS OF THESE NEW COMMITTEES AND CHAIR OF PASTORAL RELATIONS ONTO THE CHURCH BOARD OF DIRECTORS

ARTICLE VII

Board of Directors

SECTION 1: BOARD COMPOSITION

The affairs of this organization shall be administered by a Board of Directors to be composed of the Pastor, President, Vice-President, Clerk, Treasurer, four Deacons, three to four Trustees, Head Usher, Chair of Women's Fellowship, Chair of the Communications Committee, Chair of the Development Committee, Chair of the Pastoral Relations Committee, Chair of Christian Education, Chair of the Music Committee, and Chair of the Missions and Service Committee.

UPDATE 4 – ADDING A CLAUS TO ALLOW THE BOARD TO EXCEPT A RESTRICTED GIFT (OVER \$5000) AND USE IT THE SAME CALENDAR YEAR WITHOUT BRINGING IT TO THE CONGREGATION.

SECTION 7: POWERS OF THE BOARD

A. In the event the Church receives a gift restricted for a specific purpose which has not been authorized in the annual budget by the Congregation at its annual meeting, the related expenditure is nonetheless authorized, with a report being made to the congregation at its next meeting.
