1. Statement of Viability – 250 words or less

I have been endorsed by numerous LA County Judges, Democratic Clubs, and prominent individuals. I am running a well-financed professional campaign. I currently serve as a Supervising Administrative Law Judge and supervise and train other judges. Our judges decide all California cases related to Covered California, low income Medi-Cal, and foster care/county disputes.

2. What are your top issues?

Ensuring that everyone coming before me is treated with respect, including using their preferred pronouns (which I already do). It is critical that each person be seen and heard, particularly in a high stakes courtroom setting, first and foremost.

Ensuring that everyone in my courtroom is accorded the ability to fully present their case, without regard to language barriers, unfamiliarity with the justice system, any physical or mental limitations, or gender or sexual identity.

Exemplifying acceptance, fairness, the best judicial administration of justice, and competence.

3. How much do you expect your campaign to cost? How much money have you raised? How do you plan to fund the rest of your budget? I've raised over \$50k and continue to raise money from small contributors.
