

**JCAB Delegation of Power of Attorney
For Sale of Chametz**

I, _____, the undersigned, fully empower and permit Rabbi Mordechai Prus of the Jewish Center of Atlantic Beach, 100 Nassau Ave., Atlantic Beach, NY 11509, or his duly appointed agent, to act on my behalf to sell 1) all *chametz* possessed by me (knowingly, or unknowingly) as defined by the Torah and Rabbinic law, 2) any *chametz* to which I have or may have legal responsibility in whole or in part (including corporations or other business entities which own or deal in *chametz* in which I may have an ownership interest or transit goods which may be delivered to me during the period in which ownership of *chametz* is prohibited according to Torah law 3) any *chametz* that adheres to the surface of pans, pots, or cooking and usable utensils or mixtures thereof. I also empower the said Rabbi Prus or his agent to lease all places wherein the *chametz* owned by me may be found during the period commencing:

April 19th through April 27th, 2019
