In response to the ongoing provider shortage, allow individuals struggling to find services to retain their waiver slot for up to one year.



Legally Responsible Individuals (LRIs)

SB 488 (Aird); SB 149 (Suetterlein) | HB 909 (Shin); HB 1282 (Wilt)

Protects families by ensuring the regulations regarding their ability to provide paid care for their children are reasonable and appropriate.

Medicaid Works Eligibility

288 #4h (Coyner) | 288 #25s (Jordan)

Creates Medicaid Works Eligibility for DD Waiver Recipients, ensuring that people can work and earn income without risking losing their waiver.

Increase Peer Mentor Rates

288 #26h (Sickles) | 288 #27s (Jordan)

Peer Mentoring was the only direct service left out of DD Waiver Rate increases and must be increased to maintain parity with other Services.

Income Disregard to Protect Waiver Service Eligibility

HB 908 (Shin) | SB 676 (Ebbin)

Social Security Disability Insurance income is disregarded by the Department when calculating a person's financial eligibility for waivers.

Voter Protections

HB 441 (Bennett-Parker)

Ensures access to curbside voting for people with disabilities.

Protection for People When Calling First Responders

SB 357 (Boysko)

Protects people with development disabilities from prosecution for assault on an officer when that person is experiencing a crisis and calls for help.
