Wine Institute Statement on Glyphosate

California's vintners and growers are global leaders in sustainable winegrowing with a long tradition of producing high quality grapes and wines while protecting the environment.

A consumer group tested 20 alcohol beverages, including five wines, and acknowledged that the glyphosate amounts detected were low in a February 2019 report.

"Wine as a source of glyphosate should not be of concern," said Carl Winter, Professor of Food Toxicology at the University of California at Davis. "An adult would have to drink more than 140 glasses of wine a day over 70 years containing the highest glyphosate level measured to reach the level that California's Office of Environmental Health Hazard Assessment (OEHHA) has identified as 'No Significant Risk Level.'"

- **Any product used in agriculture must meet stringent safety standards** that are thoroughly reviewed and studied by the EPA, state and international governmental agencies.
- To implement wide adoption of sustainable practices, Wine Institute and the California Association of Winegrape Growers created the **California Sustainable Winegrowing Alliance** (CSWA) in 2003. CSWA's comprehensive educational program of continuous improvement focuses on key areas including: water and energy efficiency, soil health, wildlife habitat, waste management, air and water quality, employees, neighbors and communities, and pest management.
