I'd like to take a moment to wish you all peaceful and healthful new year. I can only imagine it will be better than the last.

The state of Ohio began administering COVID-19 vaccines the middle of last month. Frontline healthcare workers were among the first to receive the Pfizer vaccine along with personnel and patients of skilled nursing facilities, while first responders began receiving the Moderna vaccine. In Cuyahoga County, several hundred fire department and EMS personnel received their first dose of the Moderna Vaccine through the Cuyahoga County Board of Health, with the assistance of local fire department staff during the last week of December. Three drive-through points of dispensing or PODs were established at local fire departments and operated during the period. The locations were Independence, Westlake and Shaker Heights. The process overall went smoothly. Vaccinations should proceed using an established priority system based on vaccine supplies.

NEOFPA held their first joint monthly meeting with NEOSEN (North East Ohio Safety Educators Network) on January 6th. Our guest speaker was Ms. Brene Duggins of Holly Grove Fire Dept. NC. Her very timely topic was "Tips, Tricks, and Tools for a Virtual World". Ms. Duggins spoke for about an hour and provided a wealth of information designed to help with improving virtual presentations and training events. This was our first virtual meeting using the Microsoft Teams format.

The positions of both Vice President and Secretary were up for re-election. Both current officers Mike Kocab and I were nominated and ultimately re-elected. I am proud to carry on in my position of Secretary for another term.

The BBS had recently sent an email regarding the subject of certification renewal:

Certifications expiring between March 9, 2020 between April 1, 2021:

Full building department certifications expiring on June 30, 2020 and December 31, 2020 have until July 1, 2021 to submit your renewal application. Fire protection system designer certifications expiring during this time period have until July 1, 2021 to submit your renewal application. However, if you have completed your continuing education requirements you are encouraged to renew on time as this extension does not change the date of your next renewal.

If you have not yet completed 30 hours of continuing education required to renew your full building department personnel certification, please contact the Board office for information on online continuing education training opportunities.

Interim and trainee certifications expiring between December 31, 2019 through June 30, 2021:

In April 2020, the Board approved extensions of interim and trainee certifications expiring December 31, 2019 through June 30, 2021 until December 31, 2021.

<u>Full building department personnel certifications expiring on June 30, 2021 and after:</u>

In April 2020, the Board delayed the implementation of the code administration, existing buildings, and ethics mandatory training required to renew building department personnel certifications to begin with certifications expiring on June 30, 2021. Certification renewals due on June 30, 2021 and after must include certificates of completion of mandatory code administration (3 hrs), existing buildings (3 hrs), and ethics (1 hr) mandatory training as part of the 30 hours of required continuing education. If your certification expires on June 30, 2021 and you have not yet completed the mandatory training, please contact the Board office for information on how to access these trainings online.

Should you have any specific questions, please contact the BBS directly.

Should you "attend" a BOCONEO WebEx class and are logged in on a phone or someone else's name, be sure to notify Secretary, Monica Ferrante so we can be sure to send you your certificate. **REMEMBER**, it is your responsibility to be sure you are on the attendance roster and the BOCONEO has a valid email for you.
