### Fire Marshal's Report

As winter fades into spring many of us begin to look forward to those warm weather activities we've missed so much the past few months. One warm weather pastime I enjoy is grabbing a bite to eat at my favorite restaurants that offer outdoor dining. It seems that more and more dining establishments have expanded existing outdoor dining spaces, or have added or plan to add outdoor eating and entertainment areas. Due to our relatively short summer season and cool spring and fall evenings, a popular amenity many of these outdoor venues share are fire places or "pits" offering both warmth and ambience.

Local fire officials should be consulted when an existing place of assembly wishes to install any open flame device whether the location is within the building itself, or outside the structure in an adjacent outdoor gathering space. The fire code contains several requirements applicable to the location, installation, operation, and type of fuel used with of this type of apparatus both within and outside of the structure. For example, within an assembly space, 308.3 specifies that gas fueled heat producing equipment shall be installed in accordance with rule 6 of the Administrative Code, and that adequate precautions satisfactory to the fire code official are taken to prevent ignition of combustible materials. 308.3.1 further requires that the flame of open-flame decorative devices of this type be enclosed to prevent ignition of combustible materials in proximity to the flame. 603.1 requires the application of the IFGC for the installation of non-portable gas appliances and systems. 307.4.2.1 restricts the operation of outdoor gas-fired pits (recreational fire by definition) to no closer than 15 feet from a structure or combustible materials. 307.5 requires recreational fires to be constantly attended and a minimum 4A rated fire extinguisher be available for immediate use.

### Fire Marshal's Report

The local fire official has some authority under the Fire Code to determine what constitutes a safe installation of gas fired open flame decorative equipment within a building. These devices when installed within a building have the potential for creating burn hazards to patrons and may also provide a fuel source that could potentially create additional hazards to occupants and first responders in the event of a building fire. For example, a fire starts within the structure causing the activation of the fire sprinkler system and subsequent activation of the fire evacuation alarm. The sprinklers control the fire and, in the process also extinguish the gas-fueled flame from the indoor fire pit. Without additional equipment, raw gas could now potentially flow within the structure creating an increased risk of a secondary fire and explosion. In my opinion, such devices should be viewed with the same lens as open flame gas fired kitchen cooking equipment. The appliance should be fitted with an automatic valve that will shut off the supply of gas when either the sprinkler or fire alarm activate. In addition, this apparatus should be designed and installed in such a manner that occupants are protected from contact with the open flame and the apparatus should be located in such a manner that it does not interfere with occupants exiting the facility. Be aware of local establishments enclosing existing outdoor spaces by using rolling curtains or shades which allow them to increase their interior floor area in the colder months. Once these outdoor spaces are enclosed and are accessible from and part of the indoor assembly space, the open flame apparatus that was approved for use outside may no longer comply with the code requirements for indoor use. Other important things to consider are the materials used to enclose the formerly outdoor space, whether the means of egress fire protection and fire alarm systems have been adversely affected.

In summary, both fire and building officials should be aware of the proliferation of open flame decorative devices in commercial assembly spaces and work together to ensure their safe installation and operation.
