Greetings Members, I hope this finds you in good health and good spirits! Please allow me to wish you all an early welcome back to Normandy Party Center! Like many of you, I am really looking forward to getting together in fellowship for a good meal and some relevant education and training. I would guess most of you would agree that it has been a long and difficult road, but we made it back. See you all there!

After returning to fire inspection and prevention after nearly three years, I have run into some issues with fire protection systems I thought, in our capacity as fire code officials were long behind us and thought you might find this information interesting, if not helpful.

As you may recall, in 2001 Central Sprinkler, then an affiliate of Tyco Fire Products LP in conjunction with the Consumer Products Safety Commission instituted a voluntary recall involving around 35 million sprinklers manufactured from the mid 1970's to 2001. The sprinklers varied in style, type, and orientation and were manufactured under multiple brand names such as Central, Gem, and Star. The manufacturer provided support for those affected, assistance with identification and free replacement sprinklers. In addition, they covered the labor costs associated with the process of replacement. Benefits under the recall program were offered through August of 2007. The cause of the recall centered around those sprinklers that used a rubber O-ring seal in the assembly. The seal could potentially fail causing an obstruction that could prevent the sprinkler from operating during a fire. Many of these sprinklers were installed in high-risk occupancies such as skilled nursing facilities, hotels, hospitals, and schools.

In 2013 Honeywell Fire Systems, a division of Honeywell International instituted a recall of their very popular model BG-10 manual pull station. The device was manufactured from 1992 through 2010, however most of the devices subject to the recall were made between 1992 and 2000. The reason for the recall was an issue with a seal installed around the alarm switch within the enclosure. The seal could deteriorate over time preventing the switch from signaling an alarm when the pull station is operated. I have witnessed this occur during routine fire alarm testing. The fix is a simple and quick change-out to a new updated model. These devices were marketed under several brands including Fire-Lite, ADT, Notifier, and Johnson Controls.

Surprisingly, I have stumbled upon both of these recalled life safety devices in two different high hazard occupancies. One occupancy had both recalled sprinklers and pull stations. The failure of these devices to perform to their design parameters during a fire could end in tragedy, but together we can help to make sure this potential disaster is avoided.

It is imperative for fire code officials to closely review inspection reports and documentation provided by fire protection service providers, who typically document deficiencies in their reports of regular, required periodic inspection and testing. When these issues are noted, we can then follow up with the responsible party. Those of us who are charged with conducting inspections of occupancies triggered by work, modifications and repairs performed on fire alarm and sprinkler systems need to be mindful and aware when they are on site. A good time to catch recalled components is when plans are submitted for system repairs and upgrades due to changes in use and occupancy. As a condition of final approval, we as code officials can ask for an evaluation of the current fire protection system and request special attention be given to recalled components.
