Past President Michael Gero Independence After having served on the Board of Directors for the past two years at the request of then outgoing President Jim Decker and newly elected President Mike Gero I have learned a great deal and have enjoyed working and collaborating with my fellow board members. I look forward to serving with our newly elected officers in the months ahead.

Some of you may not be aware that I also serve on the BOD of the North Eastern Ohio Fire Prevention Association in the elected position of Secretary. I have served on the board since 2009 and have held my current position for the past 2 years. As building officials, you are as integral a part of public safety as fire officials and I invite you to consider joining our organization. Our regular meetings are held on the first Monday of every month, except holidays and the months of July and August when we observe summer recess. Our mission is similar to BOCONEO's in that we provide quality training that meets the needs of our core membership of fire code officials. Like the training BOCONEO offers to its members, the training provided by NEOFPA is designed and tailored to meet the recertification needs of its members, however unlike building officials the con-ed requirements for fire code officials is managed by the ODPS/Division of EMS in accordance with 4765 of the Ohio Administrative Code. This chapter outlines in detail among other requirements what types of training is required, who can offer the training and how many hours are needed for recertification. In Ohio fire and EMS certifications run in 3-year cycles similar to BBS and ICC certifications. Fire inspectors must obtain a minimum of 24 hours of continuing education as specified in OAC 4765 which recognizes the following 10 categories:

1) The theory of fire code enforcement, 2) enforcement of the fire codes, 3) building life safety systems, 4) the safe use and maintenance of facilities, buildings, and uses which are subject to the fire code, 5) the safe handling of materials which pose a fire hazard, 6) fire code administration, 7) legal method of code enforcement, 8) legal rights of tenants and landlords under federal, state and local laws, 9) the application, installation, use and interpretation of NFPA standards, and finally; 10) other training directly related to the performance of fire safety inspection duties. The statute requires the training to be approved by the director of a chartered training program or the applicant's Fire Chief. As the statute allows fire inspector training to be provided by recognized non-profit organizations such as NEOFPA, final approval of the training we provide must be accepted and approved by the attendees Fire Chief in order for it to be considered by the Division of EMS towards meeting the applicant's recertification requirements. Like building officials, Fire inspectors are also required to attend specialized training offered when the code is updated.

As you can see, there are some marked differences in how ongoing education for building and fire code officials is mandated, regulated, and managed. It is our goal at NEOFPA to work towards offering more training directed at both building and fire code officials and that will provide continuing education hours recognized by both the BBS and ODPS/Division of EMS. Last October we offered a day-long fire sprinkler training seminar that offered 5.5 hours of BBS credits. This year we have begun working together with the BOCONEO Board of Directors on two possible day-long seminars with topics of shared interest.
