Diaper Drop Returns for 7th Year

The 7th annual Diaper Drop will be held on May 13, 2026 from 9:00 AM-2:00 PM at the Christ Child Clothing Center.

This year The Christ Child Society will be collecting diapers for 10 agencies: The Center for the Homeless, La Casa de Amistad, YWCA, El Campito, E. Blair Warner Family Practice Center, The Salvation Army Kroc Center, Hannah's House, Northeast Neighborhood Food Pantry, St. Margaret's House, and St. Vincent de Paul, as well as CCS's Foster Hope Program. Many of the agencies are asking for the larger sizes 3, 4, 5, 6 but there is always a need for smaller sizes.

Spring is Busy at the Clothing Center

Spring is here, it seems (we hope!). Even though we do not have clients at this time, we are very busy preparing for them. Our doors will open again on August 5, and there is much to be done before then. Our buyers are busy placing orders and going to sales in stores throughout the area. Volunteers come in every Tuesday and Wednesday to sort and bundle new socks and underwear; sort and inventory new clothing items by size; add donated crocheted baby blankets to layette bags; stock new shoes and new and used boots; color-coordinate hats and gloves with new coats and hang them by size and gender; and arrange books by age and category. All items will be ready to serve clients when we open in August!

The loading dock and used clothing areas are filled with donated items that need to be sorted, sometimes needing washing or minor repairs before opening day. Since Foster Hope totes and Layettees are distributed throughout the year, items related to those specific needs are gathered and organized continually. In addition, chairpersons and volunteers involved in the annual Information Coffees in April, Diaper Drop in May, and *Let Love Shine* in November are busy preparing for those important events.

With all this activity, we are so grateful to all our volunteers who make everything go together for the benefit of the children we serve.

Volunteers Package Layettees of Hope

A crew of dedicated Christ Child volunteers prepared Layettes of Hope every Wednesday during the month of March. These newborn-size bodysuits are given to women who receive a positive pregnancy test at the three Women's Care Centers in St. Joseph County.

The volunteers open the packages of these little clothes, cut the plastic tabs off them, fold them, and insert them in the little baggies which have a CCS seal on them. They add a small card that lets Moms know CCS is

thinking of them as they prepare for this precious life.

Each year, 4,000 Layettes of Hope are requested. Over the past two years, increasing costs have made it difficult to meet this demand. As a result, Christ Child will order and distribute fewer Layettes this year.



Day of Reflection a Lenten Tradition

Thirtyfive women attended the Day of Reflection on February 25 at the Ackles Family Life Center at St. Joseph Parish, South Bend. Reverend Peter D. Rocca, CSC led reflections on the message of Pope Leo for the Lenten season.
