## On the Horizon

In life the only constant is change. The 2019-2020 Christ Child year will see many changes. We've got new board members – Mary Ann Chandler, Susan Coulter, Ruth Nieboer, Betsie Pendarvis and Susan Wendowski. Mary Ann has already signed on as co-chair of coats. Susan Coulter is a tri-chair of client referral and co-chair of Let Love Shine, Ruth Nieboer is our new Recording Secretary, Betsie Pendarvis is new VP of Clothing and Susan Wendowski is chair of LAYETTES of Hope and Speaker Coordinator. We also have a new treasurer Elizabeth Van Doren and Assistant Treasurer Linda Botich.

The Strategic Planning Committee will take on several projects. One of the first will be conducting a client survey. What we hope to determine is if we are serving clients as best we can in terms of children's clothing, services and our open hours.

Strategic Planning also recognized our membership is not growing as needed with younger, active members; this limits what we can do and threatens the future of our organization. Involved, well informed and satisfied members strengthen our ability to carry out our mission. A process to ensure that new members are integrated into the life of the organization and mentored through their first year will begin informally now with our newest members. The more formal process of instituting a "Hospitality Team" will follow.

Of major importance is our Center. The lease for our current Center at 308 S. Scott Street expires in June

2020. We need to determine whether we should renew our lease or move. And if we move, where should we move to? Within the past year we've had two leaks in the building. One occurred in the winter when the Center was closed. Fortunately some of our volunteers came to the Center to work on inventory and stocking. By that time, coats and shoes were damaged with moisture and mildew. Insurance covered the replacement costs. In July a pipe in the wall near the new clothing room disintegrated and caused damage to some of the wooden shelves. Also, we've recently seen some leaks coming from the air conditioning units. The age of our facility suggests that these types of issues will persist. And so we need to determine next steps. Shall we renew our lease? Shall we look to move to another location? Shall we lease, purchase build?

Our Center is a major concern. We need to determine our next course of action very soon. It is imperative that we learn about what our options are. And so, this fall we will hold a 'town hall' meeting to hear from real estate, architectural and financial experts on what our next steps might be. In the next few weeks we'll announce dates and times of a general membership meeting which feature presentations and/or panel discussions of our options.

This will be a very ambitious year for the organization. Please be prepared to share your thoughts and feelings on what lies ahead. As always, I appreciate your input and wisdom.

## Memories

It seems like it was just yesterday that I entered the Christ Child Center on Thomas Street. I was a little nervous because it was my first day as a volunteer. I had heard about Christ Child through a colleague and was excited about belonging to an organization that devoted their energy towards providing for children in need. I was not disappointed, I met many wonderful women who also had a love and desire to help families who were in need without the means to provide for their children especially with proper clothing.

During the spring of 1989 I was asked to take over as Principal at Saint Joseph Grade School in South Bend. My love for children was embedded in a desire to provide a solid curriculum and foster a desire to guide and support children in their faith. Missing my volunteer time at Christ Child I thought for a long time about how I could bring that joy to all of our students but especially the junior high. As a staff we researched agencies that served the community who could provide opportunities for our students to have a hands-on experience. Thus, around 1994, our junior high students began volunteering

on Wednesday mornings at the Christ Child Center and continue to do so in 2019. I often tell those who ask about the students working at the Center that I remember the very first day a group worked at the Center. They came back with exclamations over what the families at the Center were given and how shocked they were that children had a need for so many things they took for granted. This discussion led to many discussions about how we can enrich our faith in discovering how we can give of our talents to others in prayer, action, and deed.

Fast-forward to the fall of 2018 and the beginning of my third year in retirement. It was time for me to experience once again what I have always loved about Christ Child, the giving of myself in word, action, and treasure to families that need our help in so many ways. Thank you "Christ Child" and all of those I have worked with this year for bringing me home to a place that our founder, Mary Virginia Merrick, spent her life promoting "Let not a day pass without having learned something, without having overcome yourself in something, without having performed a kind act, without having accomplished something."

## A Community Partner: Rev. Cyril Fernandez

The success of South Bend Christ Child Society is, of course, due to its dedicated members, but we should also factor in our partners in the community. Among those is Fr. Cyril Fernandez, pastor at St. Patrick/St. Hedwig churches.

In his birthplace of Mangalore, India, Father's family owned a small farm with coconut and arecanut (used in medicine and candy) trees. Their culture assigns the lifelong care of parents and siblings to the oldest son, so, in step as the oldest of six children, Fr. Cyril went to engineering school. Giving it five days, he knew it was not for him. He became a missionary and worked in North India, where a lack of rain contributed to great poverty. This fueled his passion for service and confirmed his path to the Seminary. It was there that he learned English. His mother did not talk to him during those 13 years, but that changed at his Ordination when she recognized his good work.

For 15 years, he worked in India, building four schools, and acting as Principal. After witnessing local poverty in his country, he understood that by educating one child, you can educate the entire family. He started St. Xavier's English School in Jharkhand, India, in 1993 with 24 children. It continues to flourish today with over 3,000 students.

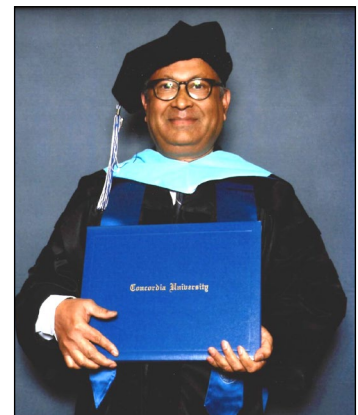
Nineteen years ago, Bishop D'Arcy invited Fr. Cyril to come to Indiana. He is not Incardinated, indicating that although he works for the Fort Wayne-South Bend diocese as a "loaned person," he belongs to the diocese of Jam-

shedpur. His Bishop from India visits here, and Father, as a US citizen, travels to India on a regular basis.

In 2008, Bishop D'Arcy recommended that Christ Child move from its falling building to the vacant school at St. Patrick. Thus the start of our partnership.

Fr. Cyril has witnessed poverty himself and sees po-  
lite compassion among our volunteers. He credits this great program to Christ Child's leadership who promote collabora-  
tion and gentleness. Father sees joy among Christ Child workers and he appreciates each work session beginning with prayer, knowing who is in need of prayer. He is aware too that our "family spirit" adds to our success.
