REGISTRATION CANCELLATION POLICIES

Refund/Substitution Policy: Cancellations, substitutions, and requests for refunds must be submitted in writing to treasurer@nvacd.org before November 6, 2023 in order to receive a refund. An administrative processing fee of \$10 will be deducted. Refunds of registration fees after November 6, 2023 will not be refunded except in extenuating circumstances that are clearly beyond the control of the registrants, such as airport closures for weather, illness or family emergencies.
