CBCS Budget Overview

2024 University Allocation

2024 Allocation from the State

- \$16.2 million for all salary increases.
 - Including \$5 million for strategic salary increases
- \$9.6 million for student success initiatives.
 - Includes expanded mental health and career services; advisors, admissions, and enrollment management
- \$16.6 million for faculty recruitment and retention.
 - \$6.3 million went to medicine

2024 Allocation from the State

- \$11.8 million for infrastructure.
 - Including building operations, public safety, and general facilities
- \$14 million directly appropriated to medicine.
 - Fund to study hyperbaric oxygen therapy on veterans with brain injuries.
- \$23.4 million for President's strategic initiative fund.

Responsibility Based Budgeting

Responsibility Based Budgeting: The Basics

- All income will flow directly to the colleges. Examples include:
 - Tuition (70% by instruction, 30% by enrollment; 100% graduate)
 - State appropriations
 - Facilities and Administration (F&A)
 - Auxiliaries
 - Grants and Contracts
 - Fees
 - Investment Income
 - DSO transfers

Responsibility Based Budgeting: The Basics

- Colleges will pay for all direct expenses they incur such as:
 - Salaries
 - Tuition Waivers
 - Scholarships, Fellowships
- Colleges will also be taxed on services by usage. For example:
 - Academic/Student Affairs (SCH)
 - Information Technology (Employee headcount)
 - Facilities (Weighted square feet)
 - Sponsored Project Administration (Research Expenditures)

Legislative Updates

1) Post-Tenure Review

- ❖ BOG Approval of Post-Tenure Regulation 10.003
- ❖ Workgroup Recommendations approved by BOT
- ❖ Review and revision of the process
- ❖ Department Unit Criteria approved
- ❖ Random selection of first round (20%) of faculty
- ❖ Selected faculty were notified

Faculty Senate Updates (continued)

2) DEI Legislation – SB266 Post-secondary Education

- ❖ Was signed into law; The bill's tenets are wide-reaching—from regulating the Gen Ed curriculum and prohibiting DEI expenditures to the hiring process
- ❖ USF's Office of the General Counsel prepared Faculty Guidance on SB 266 addressing three broad areas within the law:
 - (1) state prohibitions on expenditures related to diversity, equity, & inclusion
 - (2) powers & duties of university presidents related to faculty employment;
 - (3) updates to the requirements of the state's general education curriculum for bachelor's degree programs
- ❖ Many of the components of SB266 require additional information and regulations from the BOG



Faculty Senate Updates (continued)

Other Updates

- 3) New laws for Health: Across USF Health, several new laws impact healthcare and healthcare providers.
- 4) Still watching: Florida House Bill 7 (HB 7), known as the Stop Woke Act. A federal court issued a preliminary injunction prohibiting the Florida(BOG) and USF from enforcing HB 7.
- 5) Responsibility Center Management (RCM) Budget Model and Implementation: The new budget allocation model is toward implementation.
- 6) AI at USF: The Provost assembled a workgroup to address AI at USF; a website was created to offer suggestions for syllabi & citing generative AI



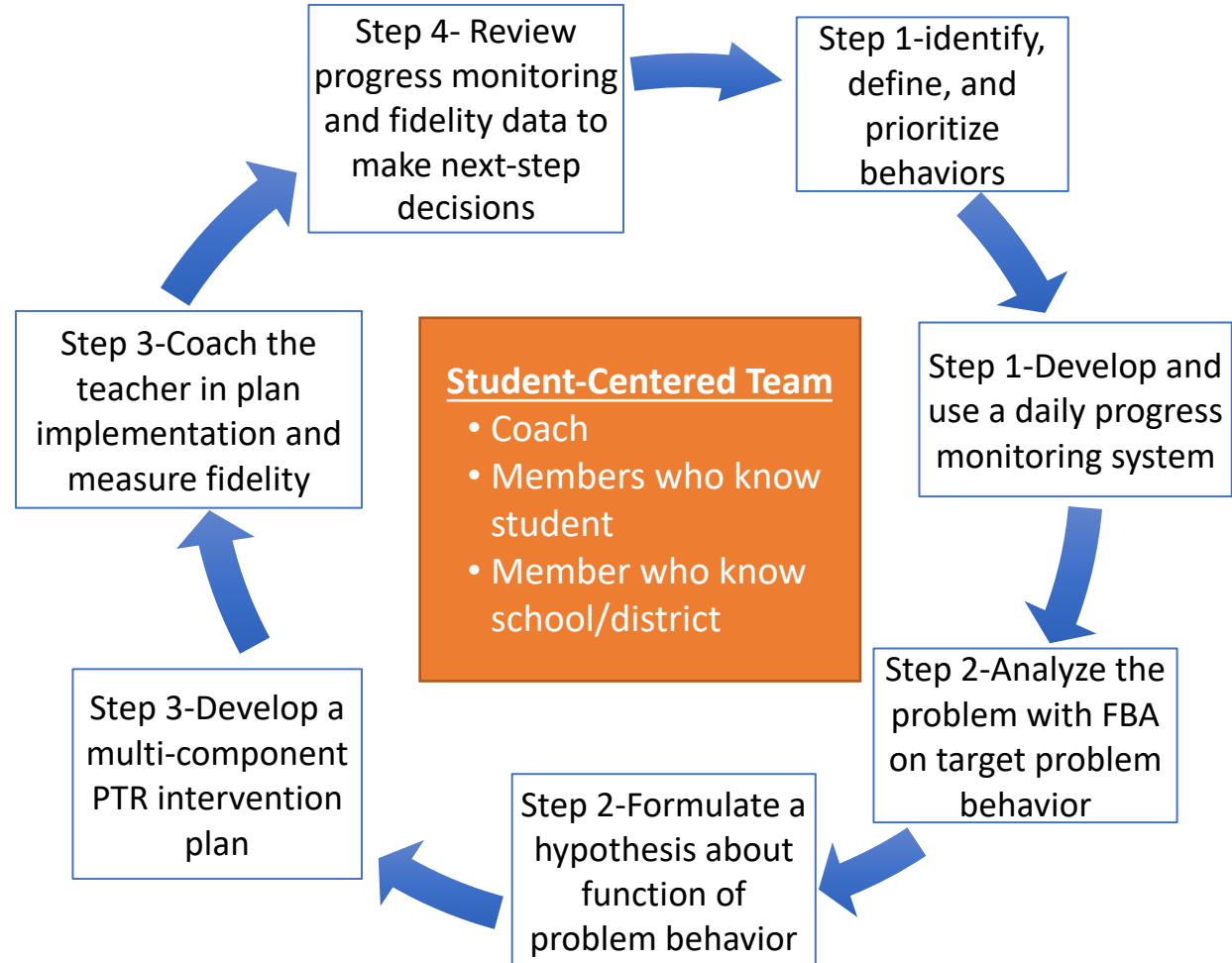

PTR 4-Step Process



ePTR Coach

- Enhanced PTR model
 - Trains school-based coaches
 - Provides virtual collaboration tools for coaches, teachers, and team members
 - Enables real-time coaching during live video observations
 - Uses virtual platforms (MS Teams & Sibme)
-



Why Virtual Coaching?

- Educational landscape changing
- Technological advancements
- Accessibility, efficiency, and flexibility
- Instant access to coaching support
- Timely guidance during classroom sessions
- Coaching support customized
- Student reactivity reduced
- Reach and impact enhanced



Why Use Virtual Platforms?

- Video conferencing tools built-in
- Screen sharing for observation and modeling
- Chat and document collaboration tools
- Coaching sessions recorded and played back
- Shared calendars for scheduling
- Centralized storage for coaching resources
- Improved security and privacy controls
- Tailored coaching platforms



Sibme

- Enables video observation, conferencing, and feedback tools
- Coaching features:
 - Goal setting and coaching plans
 - Live observation of classroom teaching
 - Annotating videos with time-stamped comments
 - Video conferencing for pre- and post-observation meetings
 - Surveys, self-assessments, and coaching plans
- Analytics and reporting on coaching activities



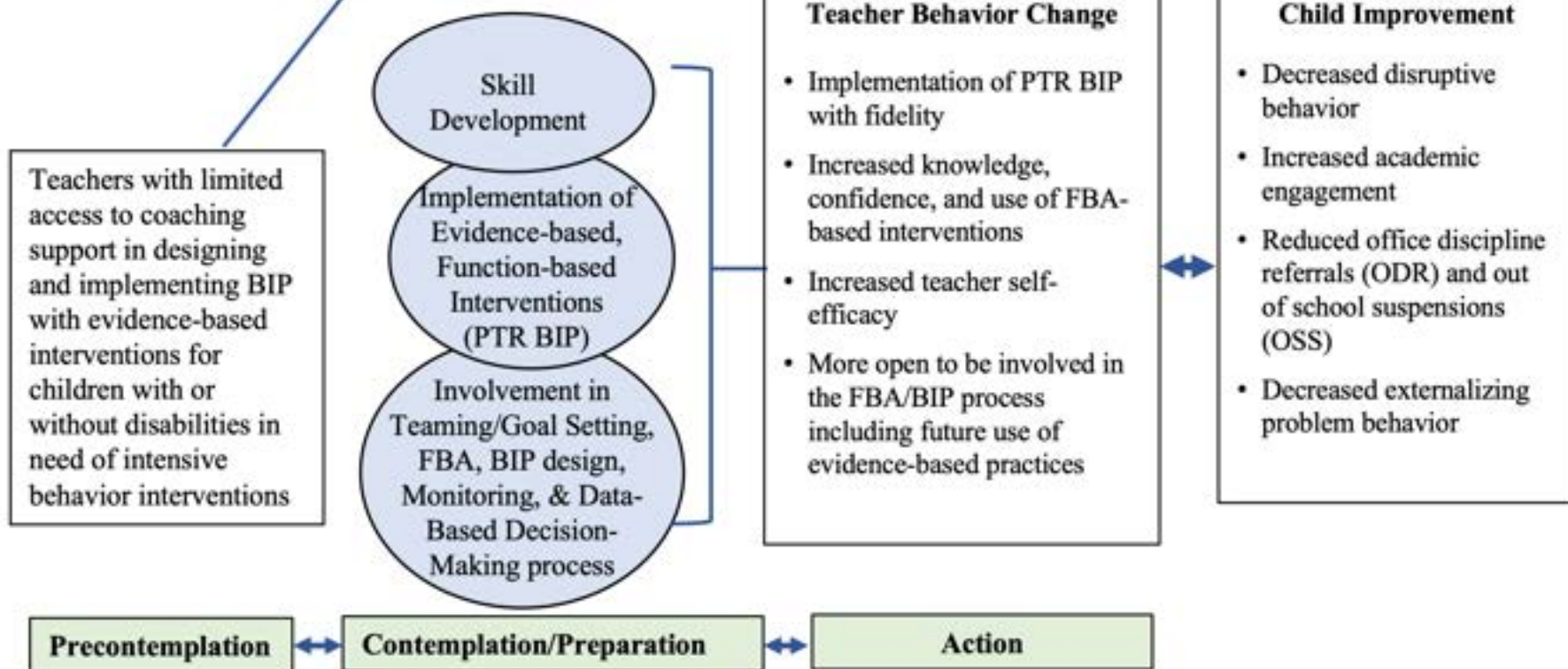

ePTR Coach Research Plan



- Phase 1 (Year 1): Development
- Phase 2 (Year 2): Feasibility Testing & Model refinement
- Phase 3 (Years 3-4): Field Study – Evaluation of the potential efficacy and const analysis
