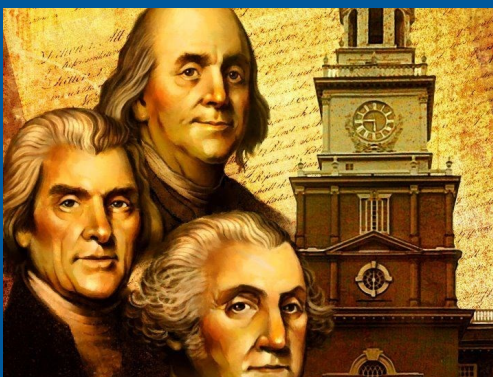

STOP **UNLAWFUL EXECUTIVE ORDERS** **4TH BRANCH AUTHORITY**

The Bill of Rights guarantee the Power of the "Sovereign People of the United States", over all branches of government. In our Republican Democracy, the Powers of, "We the People" can be exercised directly by the People or through their elected Representatives. And while Powers are delegated to the three branches of government, the "true power", remains with the People, for whom all branches exists and act.

SEPARATION OF POWER **4TH BRANCH**

The Three Branches of Government are: Legislative, Executive, and Judicial, known as the separation of powers. This balance is being threatened. The Fourth Branch must "awaken" to take its place in the hierarchy of power. The People must Act now to protect the Rule of Law upon which the entire U.S. Constitution is predicated. Fourth Branch: Protects Rule of Law.

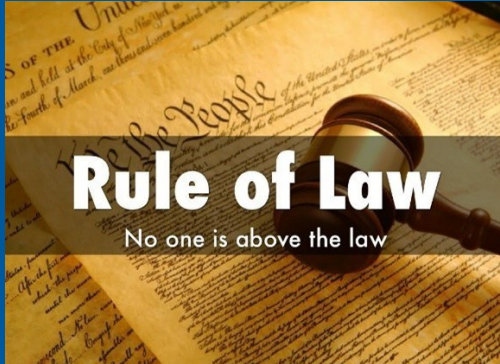
AWAKEN THE POWER OF THE **4TH BRANCH**

EMPANEL 4TH BRANCH COMMON LAW GRAND JURY IN EVERY COUNTY



The ACLU has a nationwide 50-state network of staffed offices with millions of volunteers, affiliates and activists whose mission is to defend our democracy, safe-guard our freedom, institutions and values, ensure government accountability, and protect the rights of immigrants and all people in the United States including the right to equal treatment regardless of race, sex, religion, national origin, sexual orientation, age, disability, or other classifications.

CALL TO ACTION EMERGENCY TOWN HALL ELECTIONS

Empanel 4th Branch-Common Law Grand Jury in each County. Through the 4th Branch-Common Law Grand Jury, the People have the Legal Authority to participate in the Congressional Policy making process and to unilaterally override executive orders, house bills, proposals, resolutions, blue prints, budget cuts, and court rulings. There are 3,143 counties serving as crucial units of local government. Each county gets one vote per bill on the House floor. That is **3,143** County votes compared to **218** Republican votes and **215** Democratic votes. The People's vote is higher and represents the Will of the People.

GET STARTED

1. To Empanel 4th Branch-Common Law Grand Jury
2. Call an emergency Town Hall Meeting in each county
3. People vote for 24 Community Leaders as Jurors
4. Jury Members are considered to be "elected officials"
5. This becomes the County's Standing Grand Jury Panel
6. Representing the direct voice of the People in Congress
7. The Jury is named after the county
8. Example "Kent County- 4TH BRANCH-COMMON LAW GRAND JURY"
