

## TERMS AND CONDITIONS

### FRIENDS AND FAMILY REFERRAL PROGRAM

#### TrustedPlace™

1. Program Participation: The TrustedPlace™ Friends and Family Referral Program (“Program”) is available to TrustedPlace™ customers (hereinafter “Referrer(s)”) who have an active contract in good standing at the time of referral. Referrer must be at least 18 years of age, be a U. S. resident, and have a valid e-mail and U.S. mailing address. To make a referral, Referrer must send Program e-mail notification with unique referral code to friend, family member, or colleague (hereinafter, “Referred customer(s)”).
2. Referred customers must meet the following qualifications: 1) be at least 18 years of age and a U.S. resident; 2) have a valid e-mail address; 3) purchase a contract at [Trustedplace.com/refer](http://Trustedplace.com/refer) or by calling 833.756.7451; and 3) when purchasing a contract, enter or mention Referrer’s unique referral code included in Program e-mail notification. Referred customers shall receive twenty percent (20%) off contract fee available to general public.
3. The Program is administered by The Hartford Steam Boiler Inspection and Insurance Company, One State Street, P.O. Box 5024, Hartford, CT 06102 (“HSB,” “we,” “us,” or “our”). Restrictions apply to this Program. Program not available to California residents. HSB may suspend, change, or cancel this Program at any time, without notice. HSB also reserves the right to suspend or terminate any customer’s participation in the Program for fraud, abuse, misuse, harassment, or other inappropriate or suspicious activity. Program ends May 31<sup>st</sup>, 2021.
4. Gift cards are granted to Referrer on a per contract basis, and shall be valued at fifty dollars (\$50.00 US dollars). The maximum value of gift card(s) awarded to each Referrer under these Program Terms shall not exceed \$500.00. Once a Referred customer purchases a contract, Referrer will receive an e-mail notification and HSB will mail gift card to Referrer’s address on file approximately sixty (60) days after Referred customer’s purchase. All Referred customers must be validated during the sixty (60) day time period after Referred customer’s purchase (“validation period”) in order for Referrer to receive gift card. Referred customer must keep their contract active and in good standing during the validation period. If Referred customer’s contract is terminated for any reason during the validation period, Referrer shall not receive gift card.
5. All information provided by Referrers and Referred customers ( hereinafter “parties”) to us shall be used to carry out the Program. HSB will not sell this information, and such information shall be used in accordance with our [Privacy Policy](#).
6. Compliance with Law: Referrers agree to comply with all laws, including but not limited to, the CAN SPAM Act. Any distribution of the Referrer’s unique referral code that could constitute unsolicited commercial e-mail or “spam” under any applicable regulation or law is expressly prohibited and will be grounds for immediate exclusion from this Program. Parties may not participate in the Program where doing so would be prohibited by any applicable law or regulations.
7. By participating in the Program, the parties agree to use the Program in the manner specified in these Terms and Conditions. Any individuals who do not agree to these Terms and Conditions in their entirety are not authorized to participate in the Program in any manner.
8. Gift card conditions and restrictions apply. Use of the card constitutes acceptance of the terms and conditions stated in the Cardholder Agreement. Cards will not have cash access. Must be active and in good standing when card is processed. Allow 60 days for delivery of gift card.
