

Christa's Story

Christa had done the task a hundred times before—just a routine transfer of a corrosive solvent. Her safety goggles didn't fit well over her prescription glasses, and since it was just a quick test, she left them off.

As she added a neutralizing agent to the sample, a small bubble burst, sending a splash of acidic fluid to her face. Without the full coverage and protection of proper safety eyewear, her eyes were left vulnerable.

The pain was immediate. Emergency flushing helped, but the damage was done. The chemical had burned through the cornea before the rinse could take full effect.

After an emergency trip to the optometrist for urgent care, Christa spent two weeks in the hospital, underwent two surgeries, and was off work for over a month. Her vision in the right eye was permanently impaired.



Types of Safety Eyewear in the Chemical Lab

Chemical labs are high-risk environments for eye injuries. Common hazards include chemical splashes and burns, as well as flying debris and particulates.

To combat these risks, workers should be equipped with the right type of safety eyewear, matched to the hazards they face on the job.

- **Safety glasses:** Protects against impact but does not provide protection from liquids and dust/debris.
- **Safety goggles (sealed):** Provides a tight seal around the eyes to protect from dust and debris particulates. D3- and D4-rated goggles may also provide protection from procedures involving liquids and particulate matter. The "D3" marking on safety glasses or goggles indicates that they meet the droplet and splash protection requirements. This means the eyewear is designed to protect your eyes from liquids and splashes, making it suitable for use in environments where such hazards exist, like laboratories.
- **Face shields:** Used in conjunction with safety goggles or glasses to provide additional protection. Many organizations require employees to wear both their safety eyewear and a face shield for maximum protection. The Alberta Association of Optometrists also recommends the additional layer of protection.

For workers who need vision correction, prescription safety eyewear eliminates the need to wear ill-fitting goggles over regular glasses. Employers see value in productivity, compliance and lower rates of injuries when they provide prescription safety eyewear to their employees.



The “Perfect Fit”

Incorrect fitting eyewear is almost as dangerous as no eyewear at all. If safety glasses slide, fog up, or don't seal properly, they leave workers vulnerable to injury and in almost every case, increase costs to the employer from downtime. For those who wear prescription lenses, the challenge is even greater to find the perfect fit, comfort, and durability.

Research has shown that common reasons workers forgo proper safety eyewear include poor fit, discomfort, fogging, and scratched lenses. standard-issue safety goggles often don't fit well over their frames, leading to gaps in protection and increased risk of injury.

That's why custom-fit, prescription safety eyewear is essential. It ensures:

- Full protection from hazards
- Comfort for long shifts
- Clear vision without compromise

Finding prescription safety eyewear is not easy! However, programs like Eyesafe, a non-profit prescription safety eyewear program administered by the Alberta Association of Optometrists, are helping bridge this gap.
