Location: Willamalane Park Swim Center, 1276 G Street
Springfield, OR 97477

Facility: Indoor, 25 yard pool with 8 lanes (7 feet per lane). Starting blocks at the shallow end of the pool (5'6"). Deep end is 6'0". Facility will assure that these dimensions are accurate. Off street and on street parking is available. Seating for 400 people and deck space for your own chairs, you cannot leave your items overnight. Snack bar open throughout Saturday and Sunday sessions and a hospitality room will be provided for Officials and Coaches only. The Swimming venue includes Men's and Women's locker rooms with access onto the pool deck. Facility is accessible to adaptive swimmers. Locker rooms are for youth athletes only, there are separate bathrooms around the front of the building for the public, and separate bathrooms on deck for coaches and officials.

Restrictions: Alcoholic beverages, tobacco products of any kind, and glass containers are not allowed in the swimming venue, on the grounds, or in the parking areas. There is no shaving allowed in the swimming venue. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms. Photography of any kind is prohibited behind the blocks. Deck changes are prohibited. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Deck Access: In order to serve in their official capacity, all coaches, officials, and any other person required by sanction to be members of USA Swimming must be in good standing and provide their membership credentials at check-in. Only swimmers, credentialed coaches with participating athletes, officials, authorized volunteers, and facility employees are allowed on the pool deck, behind the blocks. All others must remain in the designated spectator area or in public lobbies. Teams will be allowed 1 chaperone per 10 athletes in each session. Teams must provide names of designated chaperones prior to the session so that they can be checked in. Use the form [HERE](#) to provide chaperone names.

Spectators: Seating for spectators is in the bleachers only and is marked and chained off. All deck space for chairs is only available to swimmers, approved chaperones, and coaches.

Rules: Current USA Swimming and OSI Rules and OSI Scratch Rules will govern. OSI Safety Guidelines and Warm-up Procedures will be strictly enforced.

- MAAPP:** All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (“MAAPP”), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- Medical:** Medical supervision will be provided by facility lifeguards.
- Tech Suits:** No technical suit may be worn by any 12 & Under USA Swimming athlete member in competition at any Sanctioned, Approved or Observed meet.
- Format:** This is a timed finals meet.
- Eligibility:** Swimmers must be currently registered with USA Swimming/Oregon Swimming. A swimmer’s age on the first day of the meet applies for the entire meet. **Qualifying times (OSI A Time Standards)** must have been achieved from February 1, 2025 thru the entry deadline. If the qualifying time is not achieved by the athlete during the event swum at the meet, and proof of a qualifying time is not in the USA SWIMS Database, appropriate proof of the qualifying time must be forwarded to the OSI office within 10 days after the notification from the office. Failure to prove a qualifying time will result in a \$100 non qualifying fine from OSI. There is no on-deck registration.
- Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing racing starts or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Unaccompanied swimmers must be assigned a coach, please notify the meet director and referee if you need a coach assigned.

Warm ups may be assigned and staggered based on entries.
- Entry Limits:** Maximum of five individual events per day, and no more than 6 individual events plus 2 relays for the meet.
- Entry Deadline:** Entries will open January 1, 2026 and must be received by **noon on Wednesday, February 11, 2026.**
- Entries:** Teams with Hy-Tek or Team Unify should email an entry file and a PDF of the meet entry report to the office. The office will confirm receipt of entries by replying with two documents: a team entry report and a team fee report. Please verify the amount owed on the team fee report returned to you by the office. Please do not send a check payment, your team will be invoiced through your team account with OSI. **No payments will be accepted at the pool.** Enter personal best times achieved in the qualifying period. Seeding shall be Short Course Yards (SCY), Short Course Meters (SCM), and then Long Course Meters (LCM). Do not convert times. Non-qualifying times will not be accepted. Late entries may be submitted. Late entries for athletes who had qualifying time/s prior to the entry deadline will ONLY be accepted if space is available, as determined by meet management on a case-by-case basis. Requests for late entries may be submitted-until the new qualifying entry deadline. Late entry fees will be two times the current published Oregon Swimming Championship meet fees; to include surcharge fee, individual event fee, and relay fee (facility fee will remain the published rate). New qualifying times achieved between February 11 and February 15 will be accepted until noon on Monday February 16, 2026 by sending an email which contains the swimmer’s name, USA Swimming

ID number, event, and entry time to SC10UEntries@oregonswimming.org. Previously entered times cannot be updated. Received emails will be acknowledged by 1:30 pm on Monday. Hy-Tek Meet Manager 6 Software will be used.

Swimmers with disabilities are encouraged to enter the meet. If accommodations are required, it is the coach's responsibility to notify the Meet Director and/or Meet Referee prior to the entry deadline.

All Team or individual members entering OSI Championship meets must be in good standing with no outstanding money owed to Oregon Swimming or Oregon Swim Coaches Association. All payments must be made prior to the meet entry deadline. **Any Team or member who is not in good standing may be denied entry into Championship meets.**

- Relays:** "Relay only" swimmers must be entered in the meet and must pay the swimmer surcharge.
- Meet Results:** A Hy-Tek CommLink file and an HTML file will be posted on the Oregon Swimming website in the results section.
- Entry Fees:** \$15 Surcharge per swimmer
\$10 Facility Use Fee per swimmer
\$8 per individual event.
\$16 per relay event.

- Bull Pen:** There will be a bullpen for 8&U individual events only. All other swimmers report directly to their assigned lanes.
- Awards:** Individual events: 1st thru 8th place, Medals and 9th thru 16th place, Ribbons
Relay events: 1st thru 3rd place, Medals, 4th thru 8th place, Ribbons
- Breaks:** At the discretion of the Meet Referee, and dependent on the number of entries, breaks may be scheduled to provide adequate rest for the athletes.
- Meetings:** Officials Meetings: 1 hour prior to the start of each session
Coaches Meeting: 15 minutes prior to the start of each session if needed.
- Timers:** Each club will be assigned timing responsibilities based on the number of swimmers entered from their club.
- Officials:** The help of certified officials is needed. If you will be attending this meet, please complete an application for an assigned position by filling out the [Application to Officiate](#) which will notify the meet Referee. To be considered for an assigned position, please complete the application by January 30, 2026. The uniform for officials will be a white polo shirt, black shoes and socks, and black shorts, slacks, or skirt.
- Hospitality:** Officials and coaches are invited to enjoy the hospitality provided by TEAM Eugene Aquatics.
