Per our current by-laws:

13.7: For the Executive Committee the election of the President, Vice-President (Cultural), the Treasurers, and the Secretary (Religious) shall take place in the even numbered years. The election of the Vice-President (Religious), Secretary (Cultural), Joint Treasurer, and the Joint Secretary (Facilities) shall take place in the odd numbered years.
