





Laurier/Conestoga 2023 Tax Clinic DOCUMENT CHECKLIST

Eligibility Requirements:

You are eligible for supports with tax filing if:

- You are a student with no income
- Your income is no greater than \$35,000 for individuals OR \$45,000 for couples plus \$2,500/dependent

We won't be able to support with tax filing if:

- You are self-employed, including independent contractors
- You are a GST/HST registrant
- You have rental income, capital gains, or interest income greater than \$1,000
- You have foreign source income
- You are filing for bankruptcy, or a deceased person
- You may be classified as a Non-Resident for Tax Purposes (please tell us if you left Canada and when during 2022)

Required Information for all Tax Returns:

- Social Insurance Number (SIN) or Individual Tax Number (ITN)
- A valid government-issued photo ID
- Income earned prior to arriving in Canada for both 2023 and 2022 (if arrival date during 2023)

Recommended Information for all Tax Returns

- Direct Deposit Information (if not already set up)
- Prior year tax return/Notice of Assessment (if not your first-time filing)

Common Items for Students

- T2202 Form Tuition slip (Could be found on Laurier Quest/Conestoga Student Portal)
- T4 Form Employment slip Mailed by employer
- T4A Form Scholarships/RESP Withdrawals/CESB/CERB
- Rent Receipts Either letters from landlord or cheque copies (RENT RECEIPT/PROOF OF PAYMENT REQUIRED)
- T4E Form Employment Insurance claims
- Moving Expenses Record of expenses incurred to come to Laurier/Conestoga to study full time if your move was greater than 40 kilometers (Air, taxi, temporary accommodations and meals)
- UHIP/CIHIP Premium, other Health Insurance Premiums (RECEIPT REQUIRED)

- IF you are a newcomer to Canada in 2023 you will need to provide your income earned prior to arriving in Canada.
- Married? Children? Please let us know EVEN if your family is not with you

Less Common Items for Students

- Medical Expenses All expenses paid out-of-pocket and not reimbursed by insurance; includes insurance premiums
- RRSP contribution slips
- Student Loan Interest
- Charitable Donations
- T3/T5/T5007 Form Small investment income

Foreign Investment Property

• If you have Foreign Investment Property with a cost greater than \$100,000 CDN, you must file a *T1135 Foreign Income Verification Statement* with CRA by April 30, 2024. **THE TAX CLINIC WILL NOT COMPLETE OR FILE THE T1135 ON YOUR BEHALF.**
