In order to ensure success in New York's electric power supply industry, IPPNY is the right choice for you. We represent a diverse group of generators of all resource types that form the backbone of the state's energy supply and economy. IPPNY knows Albany and constantly monitors every legislative and regulatory action that shapes the competitive electricity marketplace on the state and federal levels. We serve as a proxy for Member companies, representing them in significant stakeholder meetings, technical conferences, and legislative hearings. We also coordinate working groups when important industry issues are at stake, bringing together Members' technical expertise with lobbying, communications, and administrative support.

When it comes to regulatory and legislative advocacy, things can move fast and on many fronts. It can be hard to keep track of what is important and relevant to your company. That is where IPPNY comes in.

### REGULATORY ADVOCACY

There are more than 300 meetings at the New York Independent System Operator (NYISO) each year. We actively monitor each meeting and participate in those affecting the generation sector.

We also spearhead the introduction and/or the refining of new market design issues through the NYISO governance process.

IPPNY monitors the activities of the New York Public Service Commission (PSC), the New York Energy Research and Development Authority, the New York Department of Environmental Conservation, the New York State Reliability Council, and the Federal Energy Regulatory Commission (FERC).

We are also an active participant in the development of environmental regulations, such as greenhouse gas emissions reductions through the Regional Greenhouse Gas Initiative.

Additionally, IPPNY maintains a national presence. We are an active member of the Electric Power Supply Association, a Washington-based industry trade association.

IPPNY also coordinates with other industry groups in the northeast on issues dealing with regional competitive markets.

### STATE GOVERNMENT RELATIONS

IPPNY promotes legislative efforts which benefit our Members, works to prevent damaging legislation, and provides access to legislators.

We maintain an active, highly visible presence in the Legislative and Executive Chambers, providing policymakers with vital information on the important role played by IPPNY Members and the competitive power markets.

### POLITICAL ACTION COMMITTEE

IPPNY Members can also participate in the political process by contributing to the IPPNY-PAC (Political Action Committee). The IPPNY-PAC represents the industry around the state and across party lines. Members can support political initiatives while enjoying social interaction at events, such as the IPPNY Annual Golf Tournament.

### GENERATING INFORMATION
