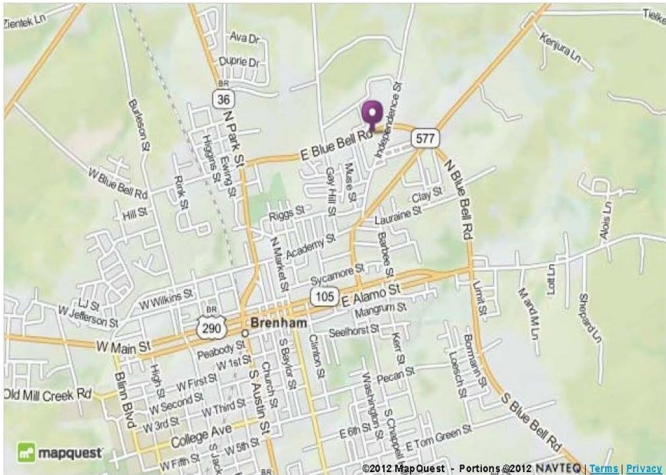

From Austin County:

Start out going northeast on E Main Street in Bellville, Texas. Turn slight right onto W Main St/ TX-36 and continue to follow TX-36. Turn left and merge onto TX-290W. Continue on TX-290W and take a right onto FM-577. The Washington County Expo will be on your left. Turn left in the Washington County Annex parking lot. Additional parking available on gravel parking lot on west side (left).

From Colorado County:

Start out going north on Fannin St/ TX-71F. Turn right onto FM 109 and continue following until Highway 36 S. Turn left onto Highway 36S. Turn left and merge onto TX-290W. Continue on TX-290W and take a right onto FM-577. The Washington County Expo will be on your left. Turn left in the Washington County Annex parking lot. Additional parking available on gravel parking lot on west side (left).

From Fayette County:

Start out going northeast on E Travis St/TX-71 Business. Turn left onto E Highway 159 and stay straight to go onto E State Highway 237. Turn slight right onto Highway 290 W. Merge onto TX-36 via the ramp on the left. Turn right onto FM-577. The Washington County Expo will be on your left. Turn left in the Washington County Annex parking lot. Additional parking available on gravel parking lot on west side (left).

(This is the address for the Washington County Extension Office which sits on the corner of FM 577 (East Blue Bell Road) and Independence Road. Turn on Independence Road and enter the third gate to the left and the Sales Facility will be the red brick front building.)

From Austin County:

Start out going northeast on E Main Street in Bellville, Texas. Turn slight right onto W Main St/ TX-36 and continue to follow TX-36. Turn left and merge onto TX-290W. Continue on TX-290W and take a right onto FM-577. The Washington County Expo will be on your left. Turn left on Independence Street.
