The Office of the University Registrar has created an online FERPA form specifically for Academic Advisors at UofSC.

Here are some important things to note about the form:

- Students complete and submit the form through an authenticated online portal. This is accepted as verification that the student is the individual submitting the form.
- Direct link to the form: go.sc.edu/ferparelease
- The form only releases the named Academic Advisor to speak to the individuals listed on the form. *This is not a blanket FERPA form for an advising office or unit.
- Students must submit a new release each Academic Year.
- Advisors will receive an email copy of the form to keep for their records and verification.
