April 14: Congressional Update from Rep. Diana DeGette

Rep. Diana DeGette is a fourth-generation Coloradoan who has dedicated her life to serving the people of Colorado's First Congressional District.

Now in her fourteenth term, DeGette is a senior member of the House Energy and Commerce Committee, and is the top Democrat on the committee's Energy, Climate and Grid Security Subcommittee. DeGette is responsible for helping shape the nation's energy policies and has worked to ensure the nation's environmental laws are being properly enforced. She has led numerous efforts to hold the nation's oil and gas producers

accountable, reduce America's overall emissions and expedite our transition to cleaner forms of renewable energy. Rep. DeGette will speak about her efforts in Congress to fight climate change and promote environmental justice.

April 21: Tech for the Anthropocene: Cultivating Earth Creatureliness

What might be the role of technology in light of what may be a finite human future? How might new and emerging technologies actually help us break through human exceptionalism, interrupt our faith in infinite growth through extraction, and cultivate a deeper sense of our earth creatureliness? To be sure, technologies can and often do have the opposite effect, alienating us from our ecological interdependence in a more-than-human world. But is that the only possibility?

Dr. Tim Beal is the Florence Harkness Professor of Religion and Chair, Department of Religious Studies, Case Western Reserve University. He has published sixteen books, most recently *When Time Is Short: Finding Our Way in the Anthropocene*
