Pledge, Waiver, Assumption of Risks and Release of All Claims

Note: THIS IS A LEGALLY BINDING AGREEMENT, Read this document carefully and in its entirety. By signing this Waiver, Assumption of Risk and Release of All Claims (this "Waiver"), you give up your right and your child's right, to bring legal action to recover damages arising out of your child's participation in any and all of the programs and activities offered by ICN Noor Academy, (operating under the Islamic Center of Naperville / "ICN") now or any time in the future.

Assumption of the Risk and Waiver Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19 has declared a worldwide pandemic by the World Health Organizations. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact.

Pledge:

All members of the ICN Noor Academy family have an important role to play in keeping our fellow students and the ICN community safe by doing our part to stop the spread of COVID-19. As a member of the ICN Noor Academy family, you know that you and your child must take steps to stay well in order to protect others and promote a safe return to school for all ICN Noor Academy families. Because of this, you pledge to take responsibility for your and your child's own health and help stop the spread of the COVID-19.

ICN Noor Academy's highest priority is the safety of its students, faculty, staff and visitors. You know that by your child engaging in school activities, including attending classes, attending activities, participating in any sports or recreation, your child and those with whom they come in close contact may be exposed to COVID-19 and other infections. You also understand that despite reasonable efforts by the school, your child can still contract COVID-19 and other infections. In order to reduce you and your child's risk, you and your child agree to be an active participant in maintaining your own health, well-being and safety, as well as the safety of others, by following all the guidelines and expectations outlined by the school.

ICN Noor Academy has in place reasonable precautionary measures aimed at preventing or reducing the spread of COVID-19 among the students. However, given the nature of the virus, ICN Noor Academy cannot **guarantee** that your child (or those with whom they come into close contact) will not become infected with COVID-19.

Waiver, Assumption of Risk and Release of All Claims:

By signing below:

- You as a parent/guardian on behalf of your child acknowledge the contagious nature of COVID-19 and **voluntarily assume all risk** that your child may be exposed to or infected with COVID-19 and that such exposure or infection may result in personal injury, illness, permanent disability, and death to your child or those with whom your child comes into close contact.
- You further acknowledge and agree to accept sole responsibility for any injuries (including, but not limited to, personal injury, disability, and death), illnesses, damages, losses, claims, causes of action, liabilities, judgements, costs and expenses, of any sort or kind, that may arise to your child or to those with whom they come into close contact with (including your household member) ("Claims")
- You hereby release, covenant not to sue, discharge, and hold harmless (ICN Noor Academy), its employees, agents, and representatives, of and from any Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.
