


Directions to the event *(From Atlanta)*

- Take I-75 South to I-475 South (Macon bypass).
- I-475 South will merge back with I-75 South.
- From I-75 South, take exit 149, which will be the Byron/Fort Valley exit.
- Turn right at the end of the ramp and proceed 11 miles to Fort Valley on State Road 49. Continue straight through the traffic light at the five-way intersection and proceed through the downtown area on Route 49/Camellia Boulevard. You will approach another traffic light at Main Street; keep straight through this light.
- Continue down Camellia Boulevard (GA-49 South) until you reach State University Drive. Make a left turn onto State University Drive.
- Continue straight and you will see the campus on your left. Enter through the main entrance.
- The C.W. Pettigrew Center will be the first building on your right.
