To point out the qualifications of those REALTORS® best fitted to be considered for leadership positions in organized real estate and to foster a spirit of competition among those who are in a position to do the real productive work of our Association, State and National Association.

#### **Rules and Guidelines:**

1. The nominee must be a RESIDENT MEMBER of the Southeastern Border Association of REALTORS®. Nominees must have REALTOR® status for current calendar year for which they are nominated.
2. Nominations received BY THE DEADLINE DATE shall be considered as eligible nominees for the year as well as nominees submitted by the committee.
3. The committee shall first consider a nominee's activities during the current year. In the event that several nominees seem equally qualified in most reasonable respects, prior year's efforts, affiliations and rewards shall be considered so as to further narrow the field.
