Current Software / Procedures

- No Efficiency
- Time Consuming
- User Intensive
- No Automation
- Limited Tracking
- Pre-Covid, mostly in-person submittals
- Post-Covid, 90% digital submittals
- Existing software is outdated
- E-mail/Drop Box



Assembly Bill 2234 (AB 2234)


- Applies timing provisions to non-discretionary post-entitlement processes (e.g., building permits, demolition permits, grading permits, and minor off-site improvement permits).
- Requires an online permit system where applicants can apply, complete, and retrieve post-entitlement permits.
- Our current programs do not comply.
- Extension approved Dec. 13, 2023
- Must be implemented Jan. 1, 2026

- Engineering




Use Cases of Accela

- Over 50 Southern California Agencies




